Explanations:**1.**

The preposition 'except' is generally followed by a gerund while 'but' is followed by an infinitive.

In option D, the preposition 'except', therefore, must be replaced with 'but' to make it a grammatically correct sentence.

Hence, option D is correct.

The sentence is absolutely correct and thus has no error in it.

The sentence is absolutely correct and thus has no error in it.

In option A, 'retiring' must be replaced with 'retirement' to make it a grammatically correct sentence.

8.

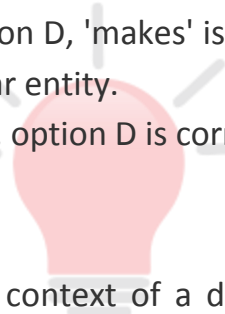
In option D, 'makes' is appropriate to use and not 'make' because, human capital is a singular entity.

In the context of a disease, use of 'suffer from' is more appropriate than that of 'suffer for'.
In part B, 'suffering for', hence, must be replaced with 'suffering from' to make it a grammatically correct sentence.
Hence, option B is correct.

In option C, the noun 'detail' must be replaced with the adjective 'detailed' as it is adding information to the noun phrase 'insurance plan'.
Hence, option C is correct.
