#### 1. Hints to Remember

Who: Nirmala Sitharaman

What: to chair 42nd GST Council meeting

When: published on 5<sup>th</sup> October 2020

Union finance minister Nirmala Sitharaman will chair the 42nd Goods and Services Tax (GST) Council meeting at 11 am on Monday.

Minister of state (MoS) for finance Anurag Thakur and finance ministers of states and union territories (UTs) will also be present at the meeting.

"Finance minister Nirmala Sitharaman will chair the 42nd GST Council meeting via video conferencing at 11 AM in New Delhi today. The meeting will be attended by MoS Anurag Thakur besides Finance Ministers of States and UTs and Senior officers from the Union Government and States," the ministry of finance wrote on Twitter.

In the last meeting held on August 27, the GST Council presented two options to states regarding GST compensation including a special window in consultation with the Reserve Bank of India (RBI) to provide Rs 97,000 crores at a reasonable interest rate and that the entire GST compensation gap of Rs 2,35,000 crores this year can be met by them in consultation with RBI.(Read more)

From the first of January onwards, the taxpayers whose annual turnover is less than Rs 5 crores will not be required to file monthly returns i.e GSTR 3B and GSTR1. They will only file quarterly returns: Finance Secretary Ajay Bhushan Pandey at the 42nd GST Council meeting.(Read more)

On October 6, 2020, India's first Pan India time use survey (TUS) titled "NSS Report- Time Use in India 2019" where NSS is National Sample Survey, was released by the Ministry of Statistics and Programme Implementation (MoSPI) in the form of 2,140-page report. It was a sample survey conducted between January and December 2019 in which 1.39 lakh households across the country and 4.47 lakh persons over the age of 6 were enumerated in measuring the participation of men and women in paid and unpaid activities.

French scientist Emmanuelle Charpentier and American Jennifer A. Doudna have won the Nobel Prize in chemistry for developing a method of genome editing known as CRISPR.

The recipients we<mark>re announ</mark>ced Wednesday in Stockholm by Goran Hansson, Secretary General of the Royal Swedish Academy of Sciences.

The prestigious award comes with a gold medal and prize money of 10 million krona (more than \$1.1 million), courtesy of a bequest left more than a century ago by the prize's creator, Swedish inventor Alfred Nobel. The amount was increased recently to adjust for inflation. (Read more)

What: to invest Rs 5,512.5 crore in RIL retail arm; joins Silver Lake, KKR among others

Sovereign wealth fund Abu Dhabi Investment Authority (ADIA) will inject Rs 5,512.5 crore into the retail division of the Mukesh Ambani-controlled Reliance Industries becoming the latest investment firm to join a rush of global investors.

The investment by ADIA in Reliance Retail Ventures Limited (RRVL) in exchange for a 1.2 percent stake values the company, India's largest retailer, at a pre-money equity value of Rs 4.285 lakh crore. RRVL has now raised a combined Rs 37,710 crore from leading global investors such as Silver Lake, KKR,



General Atlantic, Mubadala, GIC, TPG and ADIA in less than four weeks, RIL said in a statement on 6 October.(Read more)

Who: Indian Navy Helicopters

What: Undertakes Aerial Seeding FT Visakhapatnam for GVMC

When: published on 2<sup>nd</sup> October 2020

Based on a request from the District Administration, the Indian Navy is partnering with Greater Visakhapatnam Municipal Corporation (GVMC) in undertaking Aerial Seeding at Visakhapatnam. The initiative of GVMC which is aimed to enhance the green cover in and around Visakhapatnam was flagged off by Rajya Sabha MP, Shri Vijaya Sai Reddy and Vice Admiral Atul Kumar Jain PVSM, AVSM, VSM Flag Officer Commanding-in-Chief ENC in the presence of Visakhapatnam MP, Shri MVV Satyanarayana, MLAs and other dignitaries at INS Dega on 02 October 2020. Two UH3H helicopters with two tons of seed balls undertook the aerial seeding on Friday.

Naval helicopters will be airdropping a total of 50,000 seed balls weighing approx. 6.25 tonnes in five locations identified by GVMC. These locations include areas around Pedagantyada, Aganampudi, Naidu Thota, Chinamushidiwada, and Pavuralakonda in Bheemili where afforestation is planned covering an area of nearly 200 acres and are inaccessible by road and therefore aerial seeding is being undertaken with the assistance of ENC.(Read more)

Who: Alpha Design

What: Wins Rs 591 Crore Contract to upgrade Soviet-era Pechora missile system – Defence News of

India

When: published on 2<sup>nd</sup> October 2020

In a major fillip for Government's push for indigenous defence manufacturing, the Ministry of Defence (MoD) has roped in private sector players Alpha Design Technologies Limited (ADTL) to upgrade the soviet era Pechora surface to air systems, Economic Times.

ADTL will be upgrading and digitising 16 of the Pechora missile and radar systems which are presently in operation under a contract worth Rs 591 crore. Also, the contract has an options clause, under which the number of systems to be upgraded and digitised could be taken up to a total of 24 in the coming years.

It should also be noted that the project would lead to the adoption of a host of indigenously developed technologies in the Pechora missile systems, like radar transmitter, thermal imager based electro-optical system and communication equipment.(Read more)

The Russian military on Wednesday reported a successful test launch of the new Zircon hypersonic cruise missile, giving Russian President Vladimir Putin something to smile about on his 68th birthday.

Speaking to Putin via a video call, Russian General Staff chief Valery Gerasimov said the test launch was carried out Tuesday from the Admiral Groshkov frigate located in the White Sea, north of Russia.

The missile successfully hit a target in the Barents Sea, Gerasimov said.

Putin praised the successful test as "a big event" for Russia. (Read more)
