On December 2, the RBI directed the bank to temporarily stop all launches of the digital business generating activities planned under its programme Digital 2.0 (to be launched) and other proposed business generating IT applications, and sourcing of new credit card customers.

The RBI ban came after certain incidents of outages in the internet banking, mobile banking and payment utilities of the lender over the past two years. The bank had 1.48 crore credit card customers as of June.

"This is the largest ever deal and the purchase order placed by HAL (Hindustan Aeronautics) for LCA (Light Combat Aircraft)," R Madhavan, CMD, HAL said. The company is working closely with GE for its support to pursue the export potential of LCA and also to supply spares to the global supply chain of GE 404 engines, he added.

Since it first flew in January 2001, the Tejas LCA has been powered by a single General Electric (GE) F404-IN20 engine.

An offering memorandum (OM) has been prepared and shall be made available to the prospective investors in relation to the contemplated issue of notes, it said.

On August 14, Tamil Nadu will will become the third state -- after Karnataka and Andhra Pradesh -- to have a separate agricultural budget. While experts believe that this is nothing more than a political move, data available from Andhra Pradesh indicates that such a move might actually boost the sector.

The tradition of having an exclusive budget for agriculture was started by Karnataka in 2011-12 in order to give a focused approach to the sector. Andhra Pradesh followed in 2013-14, terming it as a policy paper on agriculture. Though states like Telangana, Rajasthan and Bihar too had similar plans, they did not take off due to various legal and technical reasons.
