What: inks MoU with University of Agricultural Science, Bangalore for boosting agri-exports

When: published on 4th August 2021

To give boost agricultural and processed food products exports especially from Karnataka, the Agricultural and Processed Food Products Export Development Authority (APEDA) today signed Memorandum of Understanding (MoU) with University of Agricultural Science (UAS) Bangalore.

According to the MoU, the key areas of cooperation include developing technologies jointly with APEDA for advance alertness, efficient & precision farming for enhancing quality exports; diversifying the export basket, destinations and boost high-value agri exports by establishing Brand India globally by increasing agri-exports from Karnataka under Agri Export Policy (AEP) announced by Government of India in 2018.

The collaborations between APEDA, which functions under Ministry of Commerce & UAS, will also help in strengthening forward and backward linkages, participations in international exhibitions and fairs, branding and marketing, establishment of market intelligence cell, developing traceability systems.

The APEDA and UAS, Bangalore will also facilitate participation of farmers, entrepreneurs, exporters and other stakeholders to promote agri-businesses & exports, including B2B & B2C fairs to be organised in India and abroad and also mutually cooperate in market development and traceability in millets and millet products, fresh fruits like Mango, vegetables, jaggery, processed fruits and vegetables. Promotion and hand-holding of Farmer Producer Organizations / Farmer Producer Companies and linking them with international markets will also be the part of the agreement between APEDA and UAS.

a new era of development in the state.

Sarma also said that it would launch a series of capital-intensive projects to bring about a paradigm

shift in the development narrative of the state.

What: narrates lesser-known stories from the lives of Rani Lakshmibai and Begum Hazrat Mahal

A few years after her heroic death, folk memory — in the form of songs and poems — waxed eloquent of Rani Lakshmibai's valour in the battlefield. At the same time, stories of her alleged "intemperance" spread far and wide, with the British calling her sexually promiscuous, a liquor addict with a violent temper. In sharp contrast to this stands Begum Hazrat Mahal's absence in public memory or recollection.

These are two women who never met each other, but led similar lives, with a common goal: to overthrow British rule in India. While one has been hailed a nationalist icon, the other remains shadowed in forgotten accounts. Right from their eventual rise during a pivotal moment of India's colonial history — the Revolt of 1857 — to their heroic yet poignant deaths, author Rudrangshu Mukherjee's latest non-fiction work, A Begum & A Rani — Hazrat Mahal and Lakshmibai in 1857, (published by Penguin), captures what makes them feminist icons.

In order to provide free access to information on all customs procedures and regulatory compliance, the Central Board for Indirect Taxes & Customs (CBIC) launched a dedicated portal on Wednesday. With the newly inaugurated portal, all information pertaining to Customs procedures and regulatory compliance for nearly 12,000 Customs Tariff Items can be accessed free at www.cip.icegate.gov.in/CIP. The portal would provide complete knowledge of all import and export related requirements covered under the Customs Tariff. The recent move will also boost the ease of doing cross border trade.

"CIP is yet another facilitation tool developed by CBIC to empower our business as well as any interested person with up-to-date information on the legal and procedural requirements of Customs and Partner Government Agencies (FSSAI, AQIS, PQIS, Drug Controller etc.) for carrying out imports and exports," said an official release by the ministry. Highlighting the features of CIP, the ministry said, "For using CIP, one can simply enter either the Customs Tariff Heading (CTH) or the description of the goods in question to get information to step-by-step procedures, regulatory compliances requirements like License, Certificates, etc., for imports as well as exports."

What: Recorded Highest Ever Monthly Merchandise Export of \$35.17 billion in July 2021

When: published on 3rd August 2021

India recorded exports worth \$35.2 billion in July 2021, the highest ever monthly achievement, which showed an increase of 47.91 per cent over \$23.78 billion in July 2020 and an increase of 34.06 per cent

over \$26.23 billion in July 2019.

According to figures released by the Ministry of Commerce, merchandise imports also went up to

\$46.4 billion in July 2021, leading to the trade deficit widening to \$11.2 billion during the month.

Top five commodity groups of export which recorded positive growth during July 2021 vis-à-vis July 2020 are petroleum products (215.68 per cent), gems and jewellery (130.44 per cent), other cereals (70.25 per cent), man-made yarn and fabrics (58.67 per cent) and cotton yarn and fabrics (48.02 per

cent).

What: Extended the Timeline for Banks to Implement Opening Current Accounts Norms till October

2021

The Reserve Bank of India (RBI) has allowed time to banks till October 31 to implement changes in terms of managing current accounts, following reports of small businesses being hit with account

freezing in the last few days.

The central bank cited the circulars it issued in August, November and December last year to say that these are aimed at enforcing credit discipline among the borrowers and also to facilitate better



monitoring by the lenders. The RBI, however, made it clear that a graded approach has been prescribed to banks on opening and operating of current accounts and cash credit/overdraft CC/OD facilities.

What: Partners with CWC to Offer Storage Facility for FPOs

When: published on 5th August 2021

With the aim to fulfill farmers's need of storage to store the crops especially, Central Warehousing Corporation (CWC) will give discount to Farmer Producer Organisations (FPOs), promoted by NABARD on storing, crops especially, in the storage space of agency. CWC's 423 warehouses across India have the capacity of 14.5 million tonnes.

CWC and NABARD entered into an agreement on 4th August' 2021 to assist the farmers through providing storage facilities at 30% discount. This is expected to directly benefit around 4000 FPOs, which have been established through support of NABARD.

Central Institute of Post-Harvest Engineering & Technology (CIPHET), a Ludhiana based institute, showed in its study stated post-harvest losses for all agri commodities is Rs 92,651 crore per year. Arun Kumar Shrivastav, MD at CWC, said, "Our decision to provide a 30% rebate to FPOs stems from our belief that we need to engage with these large bodies of farmers to make a substantial difference in the short and medium-term."

The India Meteorological Department (IMD) has undertaken installation of Agro-Automatic Weather Stations (AWS) at 200 places to provide exact weather forecasts to people, especially farmers, the Parliament was informed on Tuesday.

The 200 Agro-AWS installations were done at District Agromet Units (DAMUs) located in the Krishi Vigyan Kendras (KVKs) under the Indian Council of Agricultural Research (ICAR) network, to augment block-level Agromet Advisory Services (AAS) under the Gramin Krishi Mausam Sewa (GKMS) scheme, Union Minister of State Science & Technology and Earth Sciences Dr Jitendra Singh told the Rajya Sabha in a written reply.

Weather-based operational AAS viz GKMS scheme, rendered by the IMD jointly with the ICAR and State Agricultural Universities, is a step towards weather-based crop and livestock management strategies and operations for the benefit of the farming community in the country, he said.
