1. If M is the mother-in-law of Q. V is either son or daughter of M and married to H. H is not Q's sister in law's husband. Then how is V related to R?

2. How is R related to T?

Common Explanations : (Q. 1 to 3)

Reference:

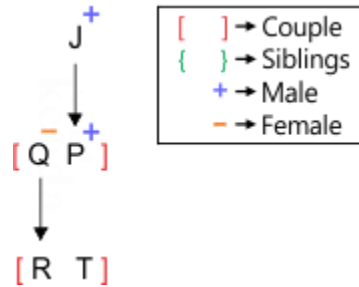
J is father-in-law of Q. Q is mother of R.

P is father-in-law of T.

There is no relation between 1 and 2. But given that, 2 married couples and total 5 members in the family.

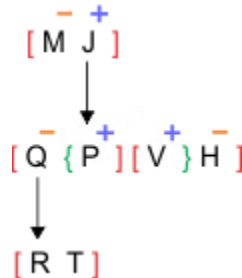
Inference:

By using this condition, P (Male) must marry to Q in order to make the condition of "2 couple in the family" satisfy. But here gender of R and T cannot be determined.



Answers :

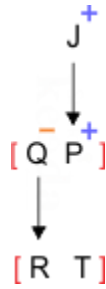
- From the following common explanation, it is clear that V is related to R as his/her "Paternal Uncle". Hence, option C is correct.



(Refer : Case :1)

<p>Case: 1 M is the grandmother of R. V is the son of M. V is married to H. Then</p> <p>V is son of M. And R is son of V's brother P. Thus V is Paternal Uncle of R.</p>	<p>Case: 2 M is the grandmother of R. V is the daughter of M. V is married to H. Then</p> <p>Here: H is Q's sister in law's (V) Husband. But in question H is not Q's sister in law's husband is given. So V is not the daughter of M.</p>

2. The following common explanation, we get "**Either Wife or Husband**".
Here, gender of R and T cannot be determined. But they are a couple. So R could be either Wife or Husband of T.



Hence, option E is correct.

3. If U is the only daughter of the family then three possible scenarios are there.
Scenario number 1, where U is the daughter of J and sister of P, in such case she would be Aunt of R.
Scenario number 2, where U is the daughter of P, in such case she would be sister of R.
Scenario number 3, where U is the daughter of R and T.
Thus we can't determine the exact relation of U and R.
Hence option D is the correct answer.

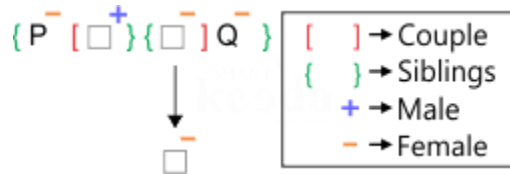
<p>Option: A</p> <p>A is the mother of S. S is brother of N. N is the father of E. E is the sister of B.</p> <p>Here A is mother of S.</p>	<p>Option: B</p> <p>E is the Brother of M. M is the sister of N. N is the Mother of A. A is the Father of S.</p> <p>Here A is the father of S.</p>
<p>Option: C</p> <p>S is the sister of E. E is the brother of A. A is the mother of M. M is the father of N.</p> <p>Here A is sister of S.</p>	<p>Option: D</p> <p>N is the mother of A. A is the brother of M. M is the father of E. E is the sister of S.</p> <p>Here A is Paternal Uncle of S</p>

Hence, option D is correct.

5. P's only brother is married to Q's sister. Both P and Q are females. Married couple has one daughter. Thus P's brother is related to Q as her brother-in-law.

Or

P's only brother is married to sister-in-law of Q. Then also both P and Q are females. Married couple has one daughter. In such a case also P's brother will be related to Q as her brother-in-law.



Hence, option A is correct.

Common Explanation: (Q. 6 to 7)

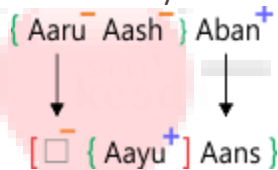
References:

Aaru and Aash are sisters, Aaif and Aban are fathers.

Aayu, who is only son in law of Aaru, is son of Aban and brother of Aans.

Inference:

Aayu, who is only son in law of Aaru, is son of Aban and brother of Aans. [It means, Aayu, who is only son-in-law of Aaru and Aayu is son of Aban and Aayu is brother of Aans.



References:

Aali is daughter of Aaif and sister of Aarv, who is son of Aaru.

There are three married couples.

Marriage is allowed among close relatives in the family.

Inference:

Given, Aali is daughter of Aaif. We know Aaif is one among the father, so he must married Aaru. Thus Aali is daughter of both Aaru & Aaif.

Aali is sister of Aarv and Aarv is son of both Aaru & Aaif.

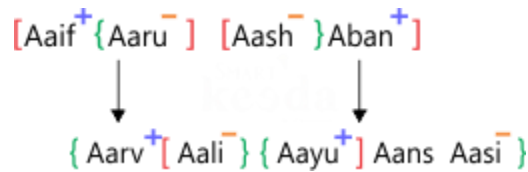
From above information, we conclude Aali and Aayu are couples since Aayu, who is only son in law of Aaru.

As there are three married couples and marriage among close relatives is allowed, which means that Aban is married with Aash that makes them the third married couple, thus Aayu and Aans are their children.

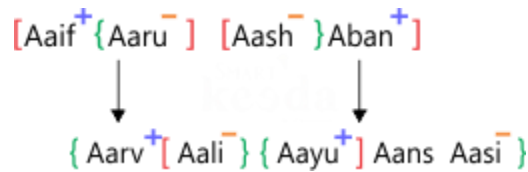

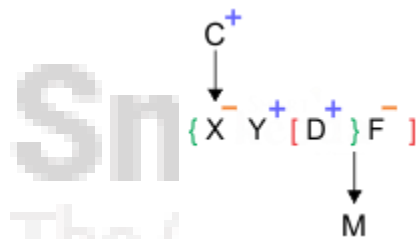
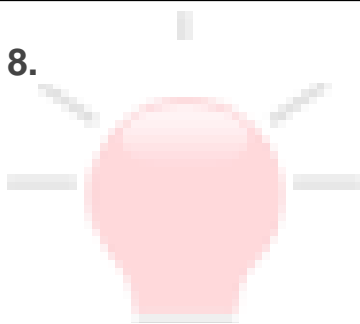
6. Following the common explanation, we get "Uncle".
Hence, option A is correct.



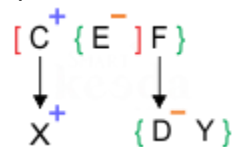
7. Following the common explanation, we get Aash is related to Aarv as his "Maternal Aunt and Aaif is related to Aayu as his Father-in-law".
Hence, option C is correct.



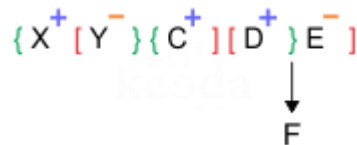

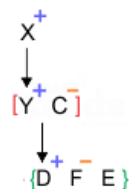
Option (A): C is Father-in-law of F as per this expression.



Option (B): C is Brother in law of F as per this expression.



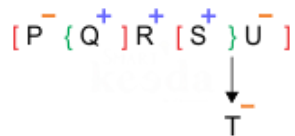
Option (C): C is Paternal Uncle of F as per this expression.



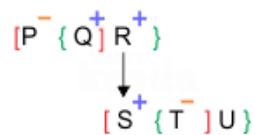
