The sequence is B-D-A-C.

Hence, option B is correct.

2. Statements *B*, *C* and *D* are choices for the starting statement. However, either *B* or *D* as the starting sentence does not enable us to make a meaningful and coherent statement. Only with *C* can we move forward. Hence, Statement *C* is the ideal choice-
