## Explanations:

1. Incorrect usage of the preposition 'to'.

The correct sentence is- I would want you to consider my request for asylum as soon as possible.

Option A is correct
2. Leader does not make sense. The correct usage would be leading.

Correct sentence- Being one of the leading multinationals in France, it offers a wide variety of differentiated products.

Hence, Option A is correct.
3. At short is incorrect and should be replaced with the correct form of the adverb; shortly.

Thus, the correct sentence will be - "Deutsche Bank, Morgan Stanley and Bank of America Merrill Lynch are leading a debt financing backing the buyout and are set to be joined by other banks shortly."

Option C is correct.
4. Has is incorrect as the sentence talks about moves (plural). The correct usage should be the plural have.

Correct sentence- Despite the war of words, there have been no outward moves from either countries indicating preparation for an actual conflict.

Hence, option A is the correct answer.
5. The fragment C is erroneous here. Both 'might' and 'likely' express possibility and use of both would bring redundancy.

Correct sentence - The two ministers laughed and deflected questions about where compromise is to be likely.

Option C is correct.
6. Whenever a sentence talks about a point of time i.e. childhood, a definite moment, 2 O' clock, morning, etc. the preposition since is used.

Correct sentence - Five years have passed since I last saw him.
Hence, option B is correct.
7. In the sentence, in the subject part, objective case of pronoun is being used which is ungrammatical. Here, 'me' must be replaced by 'I' to make sentence correct.

## With a view to (Phrase):

With the hope, aim, or intention of.
Ex. Strips of rainforest were purchased with a view to creating protected areas.
There is no error in part C as a gerund should follow the phrase 'with a view to'.
Option A is hence the correct answer.
8. His is unnecessary and incorrect. The correct sentence- With just a bag in one hand and a phone in the other, he left for the trip.

Hence, option A is correct.
9. An "inquiry" is an investigation into an incident and is paired up with the verb 'launch' and not 'compile'.

Hence, the correct answer is option A.
10. Fragment C is incorrect in saying "to and from". The correct form of the adverb is 'to and fro'.

To and fro (Idiom): in a constant movement backwards and forwards or from side to side. Hence, the correct answer is option C.
