Air forces of India and the US will begin a 12-day military exercise in Kalaikunda and Panagarh air bases in West Bengal from 2nd December 2018 with an aim to enhance operational coordination, officials said.

The 'Ex Cope India-18' will be the fourth edition in the series of bilateral drills between the Indian Air Force and the US Air Force.

This is for the first time, the exercise is being held at two air force bases, the officials said.

"The aim of the exercise is to provide operational exposure and undertake mutual exchange of best practices towards enhancing operational capability," the IAF said in a statement.

The US has sent a fleet of F15 C/D and C-130 military aircraft. The IAF is participating with the Su-30 MKI, Jaguar, Mirage 2000, C-130J and AWACS (Airborne Warning and Control System) aircraft.

India's first locomotive-less train, known as Train 18, breached the 180 kmph speed limit during a test run on Sunday, a senior railway official said here.

When this Rs 100-crore indigenously designed train is made operational, it will become the country's fastest train.

"Train 18 breached the 180 kmph speed limit in the Kota-Sawai Madhopur section. The major trials are now over, with just some more remaining. Based on the reports, fine tuning would be done if needed. As of now no major technical problem has cropped up," S Mani, general manager of Integral Coach Factory (ICF) that has manufactured the train, said.

"We expect Train 18 to commence its commercial run from January 2019. Normally the trials take three months. But now it is happening faster than expected," Mani added.

The Food Safety and Standards Authority of India (FSSAI) on Friday launched a new mass media campaign calling for the elimination of industrially produced trans fat in the food supply.

Called "Heart Attack Rewind", the 30 second public service announcement (PSA) - the first mass media campaign of its kind — will support FSSAI's global target of eliminating trans fat in India by the year 2022, a year ahead of the global target by the World Health Organization (WHO) for complete elimination of trans fat, a statement said here.

Globally, trans fat intake leads to more than 500,000 deaths of people from cardiovascular disease every year. Trans fat are made by adding hydrogen to liquid vegetable oils to make them more solid, and to increase the shelf life of foods. Trans fat are largely present in Vanaspati, margarine and bakery shortenings, and can be found in baked and fried foods.
