Deve Gowda and I.K. Gujral. He later joined the Congress and was re-elected from the same constituency in 1998, 1999, and 2004. He served as member of several parliamentary committees.

What: successfully test-fired new generation ballistic missile 'Agni-P'

When: published on 18th December 2021

On December 18, 2021, Defence Research and Development Organisation (DRDO) successfully test-fired the new generation nuclear-capable ballistic missile 'Agni Prime' from APJ Abdul Kalam island off the coast of Odisha in Balasore.

Various telemetry, radar, electro-optical stations and downrange ships positioned along the eastern coast tracked and monitored the missile trajectory and parameters. The missile followed a textbook trajectory meeting all mission objectives with a high level of accuracy.

Defence Minister Rajnath Singh extended his congratulations to DRDO for the successful flight test and expressed his gratitude for the excellent performance of the system. Taking to the micro-blogging site, the Minister said, "Congratulations to Team DRDO. The nation is proud of their achievements."

Capable of eliminating an enemy 5,000 kilometres away India has successfully test-fired the new generation nuclear-capable ballistic missile 'Agni P'. Designed and developed by Defence Research and Development Organisation (DRDO), the successful launch of the missile is in line with India's stated policy to have 'credible minimum deterrence.'

Gujarat Alkalies and Chemicals Limited (GACL) and GAIL (India) Limited signed a memorandum of understanding (MoU) for setting up a bioethanol plant with a production capacity of 500 kilo litre per day (KLD) in Gujarat.

Apart from the plant, both the companies also agreed to cooperate in other areas of mutual interest. The MoU was signed in the presence of chief minister Bhupendra Patel.

The cost of the project is estimated to the tune of Rs 1,000 crore and it is expected to generate annual revenues of approximately Rs 1,500 crores. The project will also generate direct and indirect employment for around 700 individuals, the state government said.

The Government of India and the Germany Development Bank - KfW (Kreditanstalt fur Wiederaufbau) signed a 442.26 million euros loan pact for Surat Metro Rail project. The total cost of the project is 1.5 billion euros, of which KfW is financing 442.26 million euros, a Finance Ministry statement said.

The project is being co-financed by French Development Agency, AFD (Agence Francaise de Developpemet). The Agreement with AFD for 250 million euros was signed on January 28, 2021, it said.

RBL Bank has been authorized by the Reserve Bank of India (RBI), based on a recommendation from the Controller General of Accounts, Ministry of Finance and Government of India (GoI), to collect indirect taxes on behalf of the Central Board of Indirect Taxes and Customs (CBIC).

The Bank had recently been authorised to collect Direct taxes on behalf of the Central Board of Direct Taxes (CBDT). With this announcement, the Bank can now collect Direct and Indirect taxes.

After technical integration, RBL Bank's corporate and individual customers will be able to pay their Indirect taxes through RBL Bank's mobile banking or net banking platforms as well as through the branch banking network.

The project is equally funded by the Ministry of Skill Development and Entrepreneurship (MSDE) under the Skills Acquisition and Knowledge Awareness for Livelihood Promotion (SANKALP) programme, and private philanthropy and aims to train 30,000 youth, 50% of whom will be women. The training will be conducted in Pradhan Mantri Kaushal Kendras (PMKKs) across 70 districts in COVID-resilient job roles.

The MOC approved lists in Cycling, Sailing, Shooting, Swimming, Table Tennis, Weightlifting and Wrestling as well as Para Sports (Archery, Athletics, Badminton, Shooting, Swimming, Table Tennis). Archery, Athletics, Badminton, Boxing, Equestrian, Fencing, Golf, Gymnastics, Judo, Rowing and Tennis will be taken up in the next meeting later this month.

Though planning and preparation for the 2024 Olympic Games in Paris started much earlier, the MOC meeting marks the formal start of the shortened Olympic cycle. As many as seven athletes have earned elevation from the Khelo India Scheme and are among the new inductees to TOPS Development Group.

The Reserve Bank of India has asked payment aggregators and the merchants onboarded by them to not store actual credit card data. Starting January 1, 2022, no entity in the card transaction or payment chain, other than the card issuers and/or card networks, shall store the actual card data. Instead, cardholders can get digital tokens to complete their online transactions.

Commerce and Industry Ministry said, FDI inflows in the last seven financial years is over 440 billion dollar, which is nearly 58 percent of the total FDI inflow in last 21 financial years.

The Ministry said, top five countries from where FDI Equity Inflows were received during 2014 to 2021 are Singapore, Mauritius, USA, Netherlands and Japan.
