Correct answers:

1.

Fragment D is erroneous due to use of more (comparative) instead of most (superlative). When the comparison is between more than two items/things, we always use the superlative form.

Correct statement: Forecasting for the year 2050, a UN report estimates that the percentage of urban residents in India would be 52.8 while Delhi would edge past Tokyo as the world's **most** populous city by 2028.

Hence, option D is correct.

2.

The statement is correct in its original form and has no error.

Hence, option E is correct.

3.

Fragment D has an error with respect to the use of *enchant* which means to fill (someone) with great delight/charm.

Eg: She was enchanted with the idea.

Here, the correct word would be enhance which means to intensify/increase.

Correct statement: While farm loan waivers appear to be the popular and instant solution to calm dissent, they only provide temporary relief and do little to *enhance* income or prevent future distress.

Hence, option D is correct.

4.

Fragment C contains an error with respect to use of *refers*. *Refers* is to be followed by *to*. The correct phrase would be *implies*.

Correct statement: Sluggish rural wages and sub-normal performance of the sector *implies* subdued non-farm rural activity and income.

Hence, option C is correct.

5.

Fragment A is incorrect as instead of precedence which means being considered more important than someone or something else, the word to be used is precedent meaning an earlier event or action that is regarded as an example or guide to be considered in subsequent similar circumstances.

Correct statement: If judges are allowed to easily depart from *precedent*, citizens might find themselves in an impossible position, where the statement of law remains prone to the constant vagaries of human interpretation.

Hence, option A is correct.

6.

The error is in fragment A with respect to the use of the apostrophe. The correct form would be Centre's instead of Centres. Centres refers to the multiple/plural form which is incorrect as only One Central Government is logically possible.

Correct statement: The <u>Centre's</u> somewhat <u>liberal estimate shows</u> over 60% of about 25,000 tonnes of plastic waste generated daily is collected which <u>essentially means</u> a staggering 10,000 tonnes of trash is being released into the environment, with a lot of it going into the sea.

Hence, option A contains the error.

7.

The error is in fragment D. The correct phrase is 'glimmer of hope' instead of 'glimmer for hope'.

Glimmer of hope: A very small sign that something might improve or succeed.

Eg: The survey reports a glimmer of hope for the small business sector.

Correct statement: The Taliban's announcement of a three-day ceasefire with Afghan

government troops for Eid, two days after President Ashraf Ghani declared an unconditional week-long ceasefire, is a <u>glimmer of hope</u> for a breakthrough in the long-struggling peace process.

Hence, option D is correct.

8.

Fragment C contains an error. Here, we are comparing the increasing use of regulations in international trade to the decrease in global trade post a financial crisis. To compare, the correct phrase would be 'be *similar to* the'.

Correct statement: The World Bank has **warned** that the effect of the increased use of tariffs to regulate international trade could be **similar to** the **significant drop** in global trade after the financial crisis a decade ago.

Hence, option C has the error.
