#### **Explanations:**

#### 1.

Indian constitution has total 12 schedules, each dealing with different aspect of political system in the country. 5th Schedule contains provisions related to Administration and control of Schedules areas and STs. It serves as a guarantee to indigenous population on the right over the land they live in. The schedules areas are defined as "such areas as the President may by order declared to be schedules areas."

Hence, option A is correct.

#### 2.

Eighth schedule of Indian constitution had 14 languages originally but presently there are 22 languages. It includes Hindi, Bengali, Assamese, Maithili, Malayalam, Manipuri etc. English is not included here. Latest addition was "Odia" by 96th Amendment Act 2011.

#### 3.

Originally there were 8 schedules in Indian constitution. Later on schedule 9-12 were added through constitutional amendment.

9th schedule- 1st Amendment act 1951

10th schedule- 52nd amendment act 1985

11th schedule- 73rd amendment act 1992

12th schedule- 74th amendment act 1991

Hence, option B is correct.

#### 4.

Preamble of Indian constitution is based on "Objective Resolution", drafted and moved by Pandit Nehru and adopted by the Constituent assembly in 1946. It has been amended once by 42nd amendment act to add three words" Socialist secular & integrity".

Hence, option B is correct.

#### 5.

Article 44 of the Constitution says that there should be a Uniform Civil Code. According to this article, "The State shall endeavor to secure for the citizens a uniform civil code throughout the territory of India". Since the Directive Principles are only guidelines, it is not mandatory to use them.

Hence, option A is correct.

#### 6

Article 50 of Constitution of India is a directive principle of state policy. It gives a direction to the State to keep Judiciary independent of the Executive, particularly in judicial appointments.

Hence, option A is correct.

#### 7.

Twelfth Schedule was added by the 74th Amendment Act of 1992. Twelfth Schedule of the Indian constitution contains the powers, authority and responsibilities of Municipalities. This schedule has 18 items.

Hence, option B is correct.

#### 8.

Article 226, empowers the high courts to issue, to any person or authority, including the government (in appropriate cases), directions, orders or writs, including writs in the nature of habeas corpus, mandamus, prohibition, quo warranto, certiorari or any of them.

Hence, option C is correct.

#### 9.

Initially 10 Fundamental Duties were added under article 51 A in part 4 – A through 42 amendment, Later via 86th amendment 11th Fundamental Duty was added in 2002. Fundamental Duties are basically statuary duties & are enforceable by law (Means violation of these duties can be met with punishment as prescribed by legislature of India).

Hence, option C is correct.

#### 10.

The 69th Amendment Act, 1992 has added two new Article 239AA and Article 239AB under which the Union Territory of Delhi has been given a special status. Article 239AA provides that the Union Territory of Delhi shall now be called the National Capital Territory of Delhi and its administrator shall be known as Lt. Governor. It also creates a legislative assembly for Delhi which can make laws on the state list and concurrent list except on these matters: public order, land and police. It also provides for a Council of Ministers for Delhi consisting of not more than 10% of the total number of members in the assembly. The President shall make appointments to the Council of Ministers including the Chief Minister.

Hence, option D is correct.
