Who: Germany's Toni Kroos

What: retires from international football

When: published on 2nd July 2021

Germany midfielder Toni Kroos said Friday he was retiring from international football, days after the team was knocked out of Euro 2020 by England.

"I have played 106 times for Germany. There will not be another time," wrote the 31-year-old Real Madrid player on Twitter.

"I had already made the decision to retire after this tournament for some time," he added, referring to the European championships.

What: Tests 'HELMA-P' Laser-Powered Anti-Drone System

When: published on 8th July 2021

The French military used a laser-powered canon on Wednesday to destroy a drone in a test of technology that the government hopes will be used to protect the Paris 2024 Olympic Games.

The Armed Forces Ministry said the test, conducted near the Atlantic coast in southwestern France, was a first for Europe, adding that the United States and Israel were also working on similar "Star Wars"-inspired weapons.

France plans to use the system, developed by local startup firm Cilas with public funds, to protect military bases and nuclear plants, as well as major events, against small low-flying drones that can escape radar detection.

What: implemented Web-based SPARSH for Sanction & Disbursement of Defence Pension

When: published on 9th July 2021

Ministry of Defence has implemented SPARSH [System for Pension Administration (Raksha)], an integrated system for automation of sanction and disbursement of defence pension. This web-based system processes pension claims and credits pension directly into the bank accounts of defence pensioners without relying on any external intermediary. A Pensioner Portal is available for pensioners to view their pension-related information, access services and register complaints for redressal of grievances, if any, relating to their pension matters.

SPARSH envisages the establishment of Service Centres to provide last-mile connectivity to pensioners who may be unable to directly access the SPARSH portal for any reason. In addition to several offices of the Defence Accounts Department, which are already functioning as Service Centres for pensioners, the two largest banks dealing with defence pensioners – State Bank of India (SBI) and Punjab National Bank (PNB) – have been co-opted as Service Centres.

He started the 'Hunger has no religion' initiative in his neighbourhood with his wife cooking food for the destitute for 4 to 5 months.

What: imposes penalty on 14 banks for non-compliance of rules

When: published on 8th July 2021

The Reserve Bank of India has imposed monetary penalties on 14 banks including Bank of Baroda and State Bank of India (SBI) for non-compliance of rules.

While Bank of Baroda has been fined two crore rupees, Bandhan Bank, Bank of Maharashtra, Central Bank of India, Credit Suisse, Indian Bank, IndusInd Bank, Karnataka Bank, Karur Vysya Bank, Punjab and Sind Bank, South Indian Bank, Jammu & Kashmir Bank and Utkarsh Small Finance Bank have been fine one crore rupees of penalty each. The SBI has been fined 50 lakh rupees.

In a press release, the RBI said the violations include non-compliance with certain provisions of directions issued by RBI on Lending to Non-Banking Financial Companies (NBFCs), Bank Finance to Non-Banking Financial Companies (NBFCs), and Loans and Advances - Statutory and Other Restrictions.

CMD, BDL Commodore Siddharth Mishra (Retd) stated that BDL is supplying Akash Missiles to the Indian Army and Indian Air Force. With the announcement from the Union Cabinet regarding clearance of Akash Weapon System for Export, the Company is exploring offering Akash for export to foreign countries. BDL has already received export leads from some countries expressing interest in



procuring the Missile. The Company has a well-established infrastructure and expertise to execute these orders and meet the customer delivery schedule.

What: becomes 1st SSMI to publish Transparency report under New IT rules

When: published on 1st July 2021

Google India has published its first transparency report under the new IT rules which includes details of complaints received from users in the country and the action taken across Google's platforms that are classified as "significant social media intermediaries (SSMIs)" under the rules.

The report currently covers complaints received and actioned between April 1 and April 30 this year. Google said there will be a two-month lag on reporting in a bid to allow sufficient time for data processing and validation.

The report is significant because Google is the first technology company, which qualifies as an SSMI, to have published the report under the Information Technology (Guidelines for Intermediaries and Digital Media Ethics Code) Rules, 2021. Other countries for which Google provides granular information on action taken on specific kinds of content are Turkey and South Korea.

We do have an audience which is spread out across the globe. Even an OTT platform like Mubi, which has curated content, has its set of audiences. But, our priority will still be the big screen, with the films first getting a screening in the cinemas and then coming to the OTT platform," Mr. Karun said.
