To manage hearing loss in newborn and young children, Punjab government launched an automated auditory brainstem response system (AABR) under universal newborn hearing screening programme. By doing so, Punjab has become the first state in the country to introduce the system.

Punjab health minister Balbir Singh Sidhu said the initiative will help in effective screen of hearing loss in newborn and young children.

Sharing the programme's key features, Sidhu said that after diagnosing the hearing disability in a child, the state government also provides free of cost cochlear implant which is a surgically implanted neuroprosthesis that provides a person with sensorineural hearing loss a modified sense of sound.

Sidhu said that hearing loss is one of the major birth defects in children and in a developing country like India, 5-6 per thousand children are born with this defect. He said that screening of hearing loss in newborns and children has remained a challenge considering the traditional methods available in India to date.

Researchers from Indian Institute of Technology (IIT) Madras, have developed a machine learning model that can use genome sequencing data to detect cancerous mutations in the body.

Cancer is caused by mutation or growth of cells in the body. While cell mutation is a common phenomenon, only some mutations cause cancer. They are called driver mutations. Other mutations, which are a majority of all mutations, are benign and are called passengers.

The study by three researchers from the Robert Bosch Centre for Data Science and Artificial Intelligence (RBCDSAI), IIT Madras, found that the neighbouring gene sequences of driver mutations are significantly different from that of passengers. The researchers further designed NBDriver, a mathematical model based on artificial intelligence, to identify the pathogenic variants of mutations that can cause cancer. The study, funded by the Department of Biotechnology, government of India, was published in the peer-reviewed journal Cancers in May this year.

"With India's forex reserves at 608.99 billion U.S. dollars as on June 25, 2021 stood, India has emerged as the fifth-largest foreign exchange reserves holder in the world after China, Japan, Switzerland and Russia," Minister of State Pankaj Chaudhary said at the lower house of the Indian parliament.

India's foreign exchange reserves position is comfortable in terms of import cover of more than 18 months and provides cushion against unforeseen external shocks, he said.

"Government and RBI (the Reserve Bank of India) are closely monitoring the emerging external position calibrating policies or regulations to support robust macroeconomic growth," the minister said.
