What: to resume in UAE in September-October, confirms BCCI

The remainder of the 2021 season of the Indian Premier League (IPL) will be held in the United Arab Emirates (UAE) during the September-October window.

In a Special General Meeting chaired by BCCI president Sourav Ganguly on Saturday, the Board of Control for Cricket in India (BCCI) confirmed to the State units that the tournament will have to be shifted out of India on account of 'monsoon.'

Choosing not to point to the COVID-19 crisis, the BCCI instead said India would witness heavy rains in September and therefore it wouldn't be possible to host the IPL in the country. Even though the exact dates weren't announced, it is understood that the tournament will start on September 18 or 19 and end by October 10.

**What:** expands scope of Emergency Credit Line Guarantee Scheme to aid MSME sector amid disruption caused by 2nd wave of COVID-19

When: published on 30<sup>th</sup> May 2021



The Centre today further expanded the scope of the Emergency Credit Line Guarantee Scheme (ECLGS) amid the economic disruption caused by the second wave of COVID-19 pandemic to aid Micro, Small and Medium Enterprises (MSMEs) sector.

The ministry said, Under 'ECLGS 4.0', 100 percent guarantee cover will be extended to loans of up to two crore given to hospitals, nursing homes, clinics, medical colleges for setting up on-site oxygen generation plants.

The finance ministry said, interest rate has been capped at 7.5 percent for the same. It said, Civil Aviation sector to be eligible under ECLGS 3.0. The ministry said, Validity of ECLGS extended to September 30 this year or till guarantees for an amount of 3 lakh crore rupees are issued. Disbursement under the scheme has been permitted up to December 31 this year. The current ceiling of 500 crore rupees of loan outstanding for eligibility under 'ECLGS 3.0' will be removed, subject to maximum additional ECLGS assistance to each borrower being limited to 40 percent or 200 crore rupees.

Who: Andhra Pradesh Govt

What: Switches Liquor Policy from Prohibition to Restriction

When: published on 30th May 2021

Andhra Pradesh Chief Minister Y S Jagan Mohan Reddy on Sunday announced a major shift in his government's liquor policy, moving away from prohibition (nishedham) to restriction (niyantrana). "We will implement restrictions on liquor in a phased manner to protect the families from the evil," the Chief Minister spelt out in a 16-page booklet released on Sunday, marking his government's second anniversary in office.

Two years ago when he assumed office, Jagan had promised "liquor prohibition" in a phased manner as it was "ruining families and destroying human relationships." The government had taken over the liquor business in the state to "curb liquor sale" since earning profits was not the motive. It claimed that the number of retail liquor outlets has been reduced from 4,380 to 2,934 in the last two years.

Now that the government has escrowed revenue from liquor sale and borrowed more than Rs 10,000 crore from various banks, the policy has ostensibly been changed from prohibition to restriction, top official sources pointed out. Even in the 2021-22 financial year, the AP State Development Corporation is targeting to borrow at least another Rs 16,000 crore for various schemes.

Tamil Nadu Chief Minister MK Stalin on Saturday announced ₹5 lakh assistance to children who lost both the parents due to Covid-19, news agency ANI reported.

With this, Tamil Nadu joined the league of states who have already announced financial assistance to children who lost their parents in the second wave of Covid pandemic.

States like Delhi, Andhra Pradesh, Madhya Pradesh, Kerala, Uttarakhand, and Chhattisgarh have announced assistance for such children in one form or the other.

While Delhi will bear the cost of education and upbringing of children who lost their parents, the Andhra Pradesh government will deposit ₹10 lakh for every child orphaned by infection.

What: launches scheme for families who have lost bread earner

When: published on 27th May 2021

Lieutenant Governor Manoj Sinha on Wednesday launched a Special Scheme for financial assistance to families which have lost their only bread earner due to COVID pandemic.

The J&K Government has adopted a comprehensive approach, by creating a Special Cell in Social Welfare Department to identify and track support to these families over time, in spirit of leaving no one behind. Under the scheme, called '?????' or 'Special Assistance Scheme for COVID Mortalities (SASCM)', cash assistance of Rs 1000 per month shall be provided to spouse and the eldest member of the family.

Apart from this, the scheme provides for scholarship of Rs 20,000 per annum for school going students and Rs 40,000 per annum for college going students. A family in distress shall be eligible for scholarship for two children, if they are not getting any other scholarship. The assistance is not limited to above. The Special Cell in Social Welfare Department shall also explore further assistance under other existing schemes of the government for which the family may be eligible. An important element of support shall be financial assistance for self employment for any of the surviving member who wishes to start any business for livelihood support.

What: develops new technology for COVID testing

When: published on 29th May 2021

The National Environmental Engineering Research Institute (NEERI) has developed a Saline Gargle RT-PCR Covid-19 testing method that does away with swabs and offers results in three hours.

The Indian Council of Medical Research (ICMR) has approved the new testing method last week and asked NEERI to train lab technicians and scale up its adoption across the country.

Krishna Khairnar, senior scientist, environmental virology cell with the Nagpur-based NEERI, said this test was suited for rural and tribal areas as it had minimal infrastructure requirements.

NEERI scientist expect this testing technique to be beneficial for rural and tribal areas where infrastructure requirements are a constraint and trained lab technicians were not available.

The Saline Gargle RT-PCR method is instant, comfortable and patient-friendly. The sampling can be done by the patient and results generated within three hours, Khairnar said. This method of collecting and processing the sample saves costs and does away with the RNA extraction infrastructure requirement, he said.

JB Mohapatra, a 1985-batch Indian Revenue Service officer, was given the additional charge as Central Board of Direct Taxes (CBDT) chairman after the extended tenure of incumbent PC Mody ended, a government order said.

The Central Board of Direct Taxes frames policy for the Income Tax Department.

The order issued by the department of revenue, which is under the Union finance ministry, said: "Jagannath Bidyadhar Mohapatra, member CBDT, shall discharge the duties and responsibilities of the post of chairman, CBDT, in addition to his own duties for a period of three months or till appointment of a regular chairman, whichever is earlier."

It stated that the arrangement has been "decided with the approval of the competent authority".

Official sources said an order appointing Mr Mohapatra as regular CBDT chairman could be issued in the coming days by the prime minister-headed Appointments Committee of the Cabinet (ACC).

What: cancels licence of Pune-based Shivajirao Bhosale Sahakari Bank

When: published on 31st May 2021

The RBI on Monday said it has cancelled the licence of Shivajirao Bhosale Sahakari Bank, Pune as the lender does not have adequate capital and earning prospects. As per data submitted by Shivajirao Bhosale Sahakari Bank, more than 98 per cent of the depositors will receive full amount of their deposits from the Deposit Insurance and Credit Guarantee Corporation (DICGC), the RBI said in a release.

On liquidation, every depositor would be entitled to receive deposit insurance claim amount of his/her deposits up to a monetary ceiling of Rs 5 lakh from the DICGC.

Giving details, the RBI said the bank does not have adequate capital and earning prospects and as such, it does not comply with the certain provisions of the Banking Regulation Act, 1949.

All their digitised prescriptions and saved addresses dating back to a year will be available on the PharmEasy app.
