What: targets 60 GW renewable energy capacity by 2032

When: published on 27th June 2021

State-owned power giant NTPC on Sunday said it has set a target to install 60 gigawatts (GW) of renewable energy (RE) capacity by 2032.

NTPC has become India's first energy company to declare its energy compact goals as part of the UN High-level Dialogue on Energy (HLDE), according to a statement.

"NTPC has set a target to install 60 GW of renewable energy capacity by 2032," it added.

The country's largest power producer is also aiming 10 per cent reduction in net energy intensity by 2032.

NTPC is among the few organisations globally to declare its energy compact goals.

What: remains on FATF's grey list

When: published on 25th June 2021

The Financial Action Task Force (FATF) on Friday retained Pakistan in its "grey list" for failing to adequately investigate and prosecute senior leaders and commanders of UN-designated terrorist groups.

The decision was announced at the conclusion of the multilateral watchdog's five-day virtual plenary meeting under the German presidency of Marcus Pleyer. However, FATF noted that Pakistan had completed all but one of the 27 items in the action plan drawn up for the country to tackle money laundering and terror financing when it was placed in the list of nations under increased monitoring or the grey list in 2018.

What: introduces programme to transform foundational learning with World Bank aid



When: published on 27th June 2021

Andhra Pradesh has started a programme to transform foundational learning in government schools for which the World Bank has approved a loan of 250 million dollars.

The main objectives of the programme called Supporting Andhra's Learning Transformation (SALT) are strengthening foundation schools and providing training and skill development to teachers, Andhra Pradesh Education Minister Audimulapu Suresh told The Indian Express.

"There is a dire need to improve foundational learning and the quality of education in government schools. Till now, government schools did not have LKG or UKG classes, not to mention pre-primary classes. We have started foundation schools known as pre-primary schools and have made them a part of the curriculum. About 85 per cent of a child's brain growth happens till the age of six and it is during this time the child should receive quality education, and foundation schools are key to that," Suresh said.

"In a step forward for digitising trade payments, AMNS India has executed the country's first domestic paperless bill discounting transaction," AMNS India said in a statement, adding that ICICI Bank acted as an intermediary between the the seller and the buyer, the steel maker's Baroda-based customer Vijay Tanks.

The statement also quoted AMNS India's deputy chief financial officer Amit Harlalka as saying that the move is a "positive step towards enabling the digitisation of trade payments" and that it "provides for better working capital efficiency for the company and trade partners."

What: extends restrictions on PMC Bank till December 31

When: published on 26th June 2021



The Reserve Bank of India (RBI) has extended the timeline for restrictions on Punjab and Maharashtra Cooperative (PMC) Bank till December 31, 2021 after taking into account the prospective time required for the restructuring process of the bank.

The decision came a week after the RBI granted an "in principle" approval to Centrum Financial Services for setting up a small finance bank (SFB), thereby clearing the decks for the takeover of the crisis-hit PMC Bank by Centrum and BharatPe as equal partners.

In response to the Expression of Interest (EOI) dated November 3, 2020 floated by PMC Bank for its reconstruction, certain proposals were received. After careful consideration, the proposal from Centrum Financial Services Ltd (CFSL) along with Resilient Innovation Pvt Ltd (BharatPe) has been found to be prima facie feasible, said an RBI statement.

Security personnel at the Brians 2 prison in northeast Spain tried but failed to revive him, the Associated Press reported, citing a statement from the region's government.

Olympic swim teams from top nations tend to have an alpha male leader – the swimmer with the satiated, striking swag. Sajan Prakash earned the bragging rights on Saturday, becoming the first Indian ever to clear the ‘A’ standard of international swimming, clocking 1:56.38 minutes in the 200m butterfly. While he heads to the Tokyo Olympics as the first Indian to make it to successive Games, the immensely humble and staggeringly hard working Sajan is not likely to brag about the giant splash he’s made on what is easily India’s biggest day in swimming.

Swimming in Lane 3 at the Settecolli in Rome, Italy, the 27-year-old from Kerala breached the elusive ‘A’ Cut that stands formidably at 1:56.48 min. He picked gold – his second in two weeks after coming agonisingly close to slashing ‘A’ at Belgrade, Serbia, last week.

What: Named 'Icius Tukarami' After 26/11 Martyr Tukaram Omble in Maharashtra

When: published on 29th June 2021

Two new species of jumping spiders have been discovered from the Thane-Kalyan region of Maharashtra. The scientists honoured the sacrifice of one of the hero cops of the 26/11 terror attacks, Tukaram Omble, and named one of the spider species after him. The species is called ‘Icius Tukarami.’ The discoveries published in a Russian scientific journal, Arthropoda Selecta states, “The specific epithet is dedicated to a hero of the 26/11 Mumbai terror attack, ASI Tukaram Omble AC, who took 23 bullets and captured the terrorist of the attack.” The scientific paper was published by Dhruv Prajapati,



Somnath Kumbhar, Jhon Caleb, Rajesh Sanap, and Ravi D Kamboj. One of the researchers, who published the paper, shared the news via Twitter.

The species *Icius Tukarami* is recorded in urbanized habitat in Kalyan, Thane. The species is characterised by a pair of white longitudinal stripes on the body and the unique shape of the tibial apophysis.

Who: “Enforcing Contracts Portal”

What: launched by Department of Justice

When: published on 29th June 2021

The Doing Business Report of World Bank Group benchmarks business regulations across 191 economies of the world. Within this, the Ease of Doing Business (EoDB) index is a ranking system which is an indication of an economy’s position relative to that of other economies across 11 areas of business regulation. The “Enforcing Contracts” indicator is one such essential area that measures time and cost to resolve a standardized commercial dispute as well as a series of good practices in the judiciary. Currently, only the cities of Delhi and Mumbai are under the purview of the Ease of Doing Business survey by World Bank. Kolkata and Bengaluru are likely to be included in the Doing Business Report in future.

Department of Justice, Ministry of Law and Justice, as the nodal department has been monitoring an array of legislative and policy reforms to strengthen the “Enforcing Contracts” regime for Ease of Doing Business in India in coordination with e-Committee, Supreme Court of India and the High Courts of Delhi, Bombay, Calcutta and Karnataka. In close collaboration with all of them, Department of Justice has been aggressively pursuing various reform measures to create an effective, efficient, transparent and robust ‘Contract Enforcement Regime’.

During India's chairmanship, the sessions of the Governing Body held in October 2020 and March 2021 and the 109th session of the International Labour Conference held in June 2021 were conducted through a virtual mode.

What: Wins Japan's Fukuoka Grand Prize 2021

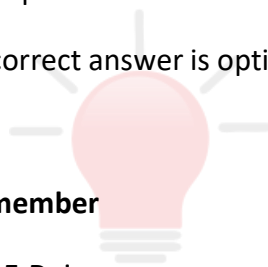
When: published on 29th June 2021

As Asia goes through turbulent changes, Mr. Sainath has been seeking new 'knowledge' and promoting civil cooperation.
