#### **Explanation:**

1. The Allahabad high court has ruled that a married daughter of a government official who dies during his service is as eligible as her married brother for the job on compassionate grounds.

Hence, option D is correct.

2. The National Pension System (NPS) is a voluntary defined contribution pension system administered and regulated by the Pension Fund Regulatory and Development Authority (PFRDA), created by an Act of the Parliament of India. The applicant is required to own and furnish PAN (Permanent Account Details) details in order to set up an NPS account, according to the eNPS portal.

Hence, option A is correct.

3. Hypothecation: Hypothecation on the other hand, is defined under the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 as a charge in or upon any movable property, existing or future, created by a borrower in favour of a secured creditor without delivery of possession of the movable property to such creditor, as a security for financial assistance and includes a floating charge and crystallisation of such charge into a fixed charge on movable property. In case of failure by the owners of the hypothecated property to repay the debt within the stipulated time, the creditor would have the option to recover its dues by way of sale of the hypothecated property.

Hence, option B is correct.

**4.** Section 420 in The Indian Penal Code: Cheating and dishonestly inducing delivery of property.— Whoever cheats and thereby dishonestly induces the person deceived to deliver any property to any person, or to make, alter or destroy the whole or any part of a valuable security, or anything which is signed or sealed, and which is capable of being converted into a valuable security, shall be punished with imprisonment of either description for a term which may extend to seven years, and shall also be liable to fine.

Hence, option D is correct.



5. The Supreme Court decided to peruse the National Green Tribunal (NGT) order directing the payment of environmental compensation charge by commercial vehicles entering Delhi, before proceeding with the hearing of a plea seeking levy of similar charges on polluting vehicles.

Hence, option A is correct.

**6.** The Supreme Court, in a 1992 order, had capped reservations in government jobs and education at 50 per cent. But in an order in July 2010, it allowed states to exceed the 50 per cent limit for reservation, provided they had solid scientific data to justify the increase.
