1. A patent is an intellectual property (IP) right for a technical invention. It allows you to prevent others from using your invention for commercial purposes for up to 20 years. You decide who is allowed to produce, sell or import your invention in those countries in which you own a valid patent

Hence, option A is correct.

2. The term alimony is derived from the Latin word 'Alimonia' which means sustenance. It is also referred to as spousal support or maintenance. It is a legal obligation of a partner to their spouse to provide financial support after the course of a divorce.

3. The Literal meaning of 'Habeas Corpus' is "we may have the body'. It is an order issued by the court to a person who has illegally detained the other person directing him to produce such person in the court for examination of detention. The person is then freed if the detention is found to be illegal.
