1. Under article 100 of the Constitution, the quorum to constitute a meeting of either House of Parliament is one-tenth of the total number of members of the House.

Hence option B is correct.

2. Question Hour

The first hour of every sitting is called Question Hour. Asking questions in Parliament is the free and unfettered right of members, and during Question Hour they may ask questions of ministers on different aspects of administration and government policy in the national and international spheres.

Hence option B is correct.

3. Education is a fundamental right but education of children below six years i.e. before primary school is not. ... The Union Ministry of Human Resource Development (HRD) is responsible for elementary education but the Ministry of Women and Child Development (WCD) looks at pre-primary education.
