A team of botanists has recently stumbled upon a new rattlepod species in the Sadasivakona grove area of Chittoor district in Andhra Pradesh, which is part of the southern Eastern ghats. The discovery has been published in the latest edition of the noted international journal 'Phytotaxa'.

During their field study, botanists P. Sivaramakrishna and P. Yugandhar from Sri Venkateswara University and Lalji Singh, Scientist-E from the Botanical Survey of India, Andaman and Nicobar regional centre, came across the species growing in the pasture lands in Sadasivakona.

After a critical investigation from July 2018 to November 2020, they found it to be a new species. ([Read more](#))

What: to buy 70% stake in Perigord Asset Holdings for Rs 182 crore

Tech Mahindra will acquire a 70 per cent stake in Ireland-based Perigord Asset Holdings Ltd for around Rs 182 crore and plans to buy the remaining 30 per cent shareholding over a period of four years.

In a statement on Monday, Tech Mahindra said the acquisition will help in augmenting its expertise in the global pharmaceutical, healthcare and life science sectors.

The company will purchase the 70 per cent stake in the Irish firm upfront for around Rs 182 crore and acquire the remaining shareholding in a phased manner, as per a regulatory filing.

According to the filing, Tech Mahindra will acquire the remaining 30 per cent stake in the company over a period of next four years at a valuation linked to the latter's financial performance. ([Read more](#))

Lacaton and Vassal, who formed their practice in 1987, have worked on private and social housing, cultural and academic institutions, public spaces, and urban developments in Europe and West Africa.

The Pritzker Prize jury commended their use of outside space, apparent in their refurbishment of La Tour Bois le Prêtre (Paris, 2011), a 17-storey, 96-unit city housing project originally built in the early 1960s, and Latapie House (Floirac, 1993), which created a garden and enhanced natural light in the building's interior.[\(Read more\)](#)

The net worth of Adani, a first-generation entrepreneur who rarely speaks publicly, has jumped \$16.2 billion in 2021 to \$50 billion, according to the Bloomberg Billionaires Index. This has made him the year's biggest wealth gainer, beating even Jeff Bezos and Elon Musk, who have tussled in 2021 for the title of world's richest. What: imposes Rs 2 crore penalty on SBI for regulatory violations

When: published on 16th March 2021

The Reserve Bank of India (RBI) has slapped a monetary penalty of Rs 2 crore on State Bank of India (SBI) for deficiencies in regulatory compliance.

The penalty is not intended to pronounce upon the validity of any transaction or agreement entered into by the bank with its customers, the central bank said in a release.

"The RBI has, by an order dated March 15, 2021, imposed a monetary penalty of Rs 2 crore on State Bank of India for contravention of provisions of section 10 (1) (b) (ii) of the Banking Regulation Act, 1949 (the Act) and specific directions of RBI issued to the bank on payment of remuneration to employees in the form of commission," it said.

The statutory inspection of SBI with reference to its financial position as on March 31, 2017, and March 31, 2018, and the Risk Assessment Reports pertaining thereto, and examination of the correspondence with the bank regarding payment of remuneration to its employees in the form of commission had revealed contravention of the provisions of the Act and specific directions issued by RBI.[\(Read more\)](#)

When: published on 17th March 2021

Country's largest commercial bank, State Bank of India (SBI) has been awarded the mandate for the first SOFR (Secured Overnight Financing Rate) linked ECB deal by Indian Oil Corporation Limited (IOCL). SOFR is an identified replacement for USD LIBOR which is expected to be phased out at the end of 2021. The sunset has been triggered by the decision of Financial Conduct Authority (FCA) in UK not to compel contributing banks for LIBOR calculation after December 2021.

On this occasion, Deputy Managing Director (International Banking Group), Shri C Venkat Nageswar, said, "It is the first SOFR deal in the ECB space and the transaction demonstrates SBI's position as a



leader in aligning its systems and processes to embrace Alternate Reference Rates (ARRs). IOCL, the largest public sector Oil Marketing Company in India, by availing the first SOFR linked ECB, will set the pace for smooth transition by Indian Corporates to ARR mechanism.”([Read more](#))

What: approved to establish Ratle Hydroelectric Power Corporation to develop 850 MW HEP on Chenab River

When: published on 18th March 2021

The J&K Administrative Council (AC), which met in Srinagar under the chairmanship of Lieutenant Governor, Manoj Sinha, on Tuesday approved the incorporation of the Joint Venture Company (JVC) under the name Ratle Hydro-electric Power Corporation to implement the 850 MW Ratle Hydro-Electric Project (HEP) on river Chenab at Drabshala in Kishtwar, Jammu and Kashmir, officials said.

The proposed JVC will have authorised capital of Rs 1,600 Crore with an initial paid-up capital of Rs 100 Crore, out of which the Jammu and Kashmir State Power Development Corporation (JKSPDCL) will contribute Rs 49 crore as initial equity.

The Memorandum of Understanding (MoU), to execute the project, was signed between the Government of Jammu and Kashmir, JKSPDCL and NHPC on 03.01.2021 in the presence of the Lieutenant Governor.[\(Read more\)](#)

It is an umbrella body for the ordnance factories and related institutions, and is currently a subordinate office of the Ministry of Defence (MoD).

The IOFs play a vital role in the production, testing, logistics, research, development, and marketing of a comprehensive product range in the area of land, sea and air systems. It is the need of every country to have proper arms and ammunition for the security of the citizens. Popularly known as the Fourth Arm of Defence, the Ordnance Factories Board is one of the four arms of defence in the country, along with the Indian Army, the Indian Air Force and the Indian Navy. The history of Ordnance Factory and this day has its roots stuck deep into the times of the British Rule in India. In 1775, East India Company founded the Ordnance Board at Fort William in Calcutta.
