What: okays reclassification of NIACL as "public investor" from "promoter"

When: published on 28th April 2021

Public sector insurer The New India Assurance Co Ltd (NIACL) has been reclassified as a "public shareholder" of Axis Bank from being a "promoter" earlier, the private sector lender said on Wednesday.

Last week, the country's third-largest private sector lender had received a request from NIACL to reclassify it to public category from promoter category investor.

In a regulatory filing, Axis Bank said a letter was placed for the consideration of the board at its meeting held on April 28, 2021. "The board at the meeting has considered and approved the said request received from NIACL to reclassify it to public category from promoter category," .

The nod for the reclassification is subject to approval of the stock exchanges, statutory/regulatory authorities and shareholders of the bank. ([Read more](#))

What: Is First Country to Green Light Self-Driving Cars on Motorways

When: published on 28th April 2021

The UK government on Wednesday became the first country to announce it will regulate the use of self-driving vehicles at slow speeds on motorways, with the first such cars possibly appearing on public roads as soon as this year.

Britain’s transport ministry said it was working on specific wording to update the country’s highway code for the safe use of self-driving vehicle systems, starting with Automated Lane Keeping Systems (ALKS) – which use sensors and software to keep cars within a lane, allowing them to accelerate and brake without driver input. The Cabinet on Wednesday approved the signing of an agreement between India and the UK for sharing information and prevent Customs offences. "The Cabinet, chaired by Prime Minister Shri Narendra Modi, has approved the signing and ratification of an Agreement between the Government of Republic of India and the Government of the United Kingdom of Great Britain and Northern Ireland on Customs Cooperation and Mutual Administrative Assistance in Customs Matters," an official statement said.

The agreement will help in the availability of relevant information for the prevention and investigation of Customs offences.

Who: India's first 3D printed house

What: by IIT Madras startup



When: published on 30th April 2021

India's first 3D printed house is here. Tvasta Manufacturing Solutions, an IIT Madras alumni founded startup, took the initiative and built it in five days. The house was inaugurated by Union Finance Minister, Nirmala Sitharaman, early this week. Tvasta Manufacturing is part of the ASHA incubator of the Ministry of Housing and Urban Affairs at IIT Madras.

The house, built in collaboration with Habitat for Humanity Terwilliger Center for Innovation in Shelter, is single storey, 600 sq feet and constructed with indigenous concrete 3D printing technology.

Tvasta on its blogpost mentions the intricacies of the technology. Tvasta's goals are to make the structures affordable and sustainable. "The mix is based on ordinary Portland cement, but with lower water-cement ratio, reinforced with either amorphous metal fibers or plastic fibers. The 3D printers are capable of printing with aggregates up to 8 mm," reads the post. ([Read more](#))

What: passes away

When: published on 29th April 2021

NASA astronaut Michael Collins, who piloted the historic mission of Apollo 11 spacecraft Columbia in 1969, passed away on Wednesday due to cancer. He was 90.

During the 1969 Apollo 11 mission, Collins remained in lunar orbit while fellow crew members Neil Armstrong and Buzz Aldrin descended to the moon's surface in the lunar module.

When Armstrong and Aldrin descended to the moon's surface on July 20, Collins was orbiting 65 miles above them and was momentarily almost forgotten as the world's attention focused on his two crewmates below. ([Read more](#))

Ayushman Bharat Yojna was launched by Prime Minister Narendra Modi in 2018, to provide healthcare benefits to crores of Indians who can't afford proper medical facilities. The flagship scheme of the Narendra Modi government was launched along the lines of a universal health coverage to meet one of the Sustainable Development Goals (SDGs) of the United Nations - "leave no one behind." According to Health Minister, Dr Harsh Vardhan, India has operationalised 75,532 Ayushman Bharat-Health and Wellness Centres (HCW) so far despite the COVID-19 pandemic and is on track to functionalise 1.5 lakh HWCs by December 2022. What: Launched in Albania

When: published on 29th April 2021

NATO has launched joint military exercises in Albania with thousands of military forces from the United States and other countries in the first such large-scale drills since World War II in the Western Balkans, a U.S. army official said Thursday.

Col. Joseph Scrocca said "a staunch NATO ally since 2009, Albania is a valued security partner — both regionally and globally."

Albania is playing a critical part in the DEFENDER-Europe 21 exercise with Joint Logistics Over-the-Shore operations taking place "for the first time in Europe since World War II at the Port of Durres," Scrocca said in an online briefing.

The sealift ship USNS Bob Hope will demonstrate the unloading of heavy equipment onto smaller vessels that will transfer the cargo to shore for onward movement. ([Read more](#))

What: launches another 36 LEO satellites from Russian cosmodrome

When: published on 26th April 2021

OneWeb, a Low Earth Orbit (LEO) satellite communications operator, co-owned by Bharti Global and the UK government, launched another batch of 36 satellites by Arianespace from the Vostochny cosmodrome in Russia.

The latest launch takes OneWeb's total in-orbit constellation to 182 satellites. These would form part of OneWeb's 648 LEO satellite fleet that will deliver high-speed, low-latency global connectivity.

The latest launch of LEO satellites will enable OneWeb to offer services across the UK, Alaska, Northern Europe, Greenland, Iceland, the Arctic seas and Canada, and will be switched on before the end of the year. OneWeb intends to make global service available next year, including in India.

OneWeb CEO Neil Masterson, in an official statement Monday, said the company is "rapidly building momentum, launching more satellites, demonstrating the network and announcing more distribution signings around the globe". [\(Read more\)](#)

What: passes away at 91 after contracting Covid-19

Veteran lawyer and former attorney general Soli Sorabjee passed away on Friday morning after contracting the coronavirus disease (Covid-19). Sorabjee was 91. He was admitted to a private hospital in Delhi.



Sorabjee, a Padma Vibhushan recipient, began his legal practice in 1953 in Bombay High Court and he was designated senior counsel of the Supreme Court in 1971. He became the attorney general of India first from 1989-90 and then from 1998-2004. He was appointed by the United Nations as a Special Rapporteur for Nigeria in 1997 to report on the human rights situation in that country. Following this, he became a member and later chairman of the UN Sub Commission on the Promotion and Protection of Human Rights from 1998 to 2004. ([Read more](#))

Ace Indian swimmer Srihari Nataraj created a national record in 50m backstroke while winning his second gold of the Uzbekistan Open Championship here.

The 20-year-old clocked 25.11 seconds to bag the top prize in the FINA-accredited Olympic qualifying event on Saturday night.

Indian swimmers enjoyed a rich haul of 29 medals -- 18 gold, seven silver and four bronze -- in the meet.

It was Srihari's third national record in two days as the Bengaluru swimmer had rewritten the national marks twice in 100m backstroke, his pet event, earlier this week.
