Who: Cabinet

What: gave approval for several initiatives

When: published on 5th May 2021

Recently, the Union Cabinet chaired by Prime Minister Narendra Modi gave approval for several initiatives.

#### The initiatives are:

Additional foodgrain under Phase-III of Pradhan Mantri Garib Kalyan Anna Yojana (PM-GKAY).

MoU between India & United Kingdom (UK) on Global Innovation Partnership (GIP).

MoU between India & UK on Migration and Mobility Partnership (MMP).

#### Allocation of additional foodgrain under PM-GKAY:

The cabinet has accorded approval to the allocation of additional foodgrain under Phase-III of PM-GKAY for another period of 2 months – May to June 2021.

Each beneficiary will get 5 Kg of rice per month for free of cost.

It is set to benefit around 79.88 Crore people covered under NFSA (National Food Security Act)

The Allocations are aimed at alleviating the hardships faced by the poor due to economic disruption caused by Covid-19.

#### MoU between India & UK on GIP:

The cabinet has accorded approval to the signing of MoU between India and the UK on the Global Innovation Partnership (GIP). It will support Indian Innovators to increase their innovations in developing countries thereby helping them explore new markets and become self-sustainable.

#### Approval for MoU between India & UK on MMP:

The Cabinet has approved the signing of MoU on Migration and Mobility Partnership between India & UK.

It aims to ease the mobility of students, researchers and skills professionals between the two countries & tackle the issues related to irregular migration and human trafficking.



#### 2. Hints to Remember

Who: Labour Ministry

What: notifies Section 142 of Social Security Code, 2020

When: published on 5th May 2021

Section 142 of the Social Security Code, 2020 has been notified by Ministry of Labour & Employment covering applicability of Aaadhar. The notification of section will enable Ministry of Labour and Employment to collect Aaadhar details for the database of beneficiaries under various social security schemes.

National Data Base for unorganised workers (NDUW) is at an advanced stage of development by National Informatics Centre. The portal is aimed at collection of data for unorganised workers including migrant workers for the purpose of giving benefits of the various schemes of the Government. An inter-state migrant worker can register himself on the portal on the basis of submission of Aaadhar alone.

Union Minister of State (I/c) for Labour and Employment Shri Santosh Gangwar has clarified that the section under the Social Security Code has been notified only for collection of data of workers including migrant workers. No benefit will be denied to workers for want of Aaadhar. (Read more)

According to an official statement, the Chief Minister appreciated the efforts of the Information Technology (IT) department and said: "This helpline is unique in itself by ensuring effective use of technology in facilitating the people."

The callers can call on toll free number 1100 from 7 am to 10 pm for seeking help regarding the coronavirus-related problem. The call executive would register the complaint and contact concerned authorities for providing necessary help to the person regarding various issues such as test, vaccination, home quarantine, medicines, ambulance and Oxygen. The International Amateur Athletic Federation (IAAF) was founded on 17 July, 1912 in Sweden's

Stockholm. The name later changed to the International Association of Athletics Federations.

In 2019, the organisation became World Athletics. It is the governing body for the sport of track and field athletics. The many roles of World Athletics as a world governing authority are to create a competition programme, to standardise technical equipment, and to prepare a list of official world

records.

World Athletics Day was founded back in 1996 when World Athletics was the International

Padma Shri awardee music composer Vanraj Bhatia passed away on Friday at the age of 93. The veteran musician was reportedly battling poor health and financial constraints.

As per reports, his health further deteriorated for the last couple of months while he remained with only a little activity at his home, where he ultimately passed away.

The legendary composer had won the National Film Award for Best Music for Govind Nihalani's 'Tamas' in 1988 and the Padma Shri in 2012. He carved his niche with his distinct notes in the seventies and the eighties in the art cinema circuit.(Read more)

Who: Assam: Former Union Minister and TV tycoon Matang Sinh

What: dies of COVID-19

When: published on 6th May 2021

Former Union Minister and veteran Congress leader Matang Sinh has died due to COVID-19.

Matang Sinh was 58 years old at the time of his demise.

Matang Sinh was a close aide of former Prime Minister PV Narsimha Rao, and served as a union minister in his Government.

Matang Sinh was well known in Assam as a TV tycoon.

Matang Sinh had introduced Assam and the Northeast to satellite television by launching the region's first satellite news channel – Northeast Television (popularly know as NETV) in 2003.



He was elected to Rajya Sabha from Assam in 1992 and served as union minister of state in parliamentary affairs from 1994 to 1998. (Read more)

#### 9. Hints to Remember

Who: World's first 2 nanometer chip technology

What: unveiled by IBM

When: published on 7th May 2021

IBM introduced what it says is the world's first 2-nanometre chipmaking technology. The technology could be as much as 45 percent faster than the mainstream 7nm chips in many of today's laptops and phones and up to 75 percent more power efficient, the company said.

The technology likely will take several years to come to market. Once a major manufacturer of chips, IBM now outsources its high-volume chip production to Samsung Electronics but maintains a chip manufacturing research centre in Albany, New York that produces test runs of chips and has joint technology development deals with Samsung and Intel Corp to use IBM's chipmaking technology.

The 2nm chips will be smaller and faster than today's leading edge 5nm chips, which are just now showing up in premium smartphones like Apple's iPhone 12 models, and the 3nm chips expected to come after 5nm.(Read more)

Steel Authority of India Ltd (SAIL) on Tuesday regained market capitalisation (m-cap) of Rs 50,000 crore, after its stock climbed over 80 per cent in the past one and half month, on expectations of strong earnings in March quarter (Q4FY21) and a healthy outlook going forward.

The state-owned steel major also entered into the league of top 100 most valued companies in terms of market capitalisation. At 10:19 am, SAIL stood at 78th position in the overall m-cap ranking with a market cap of Rs 55,529 crore, BSE data shows.



In the intra-day today, the stock hit an over nine-year high of Rs 135.60, up 6 per cent, on the BSE. In the past six weeks, it has zoomed 85 per cent, as compared to a 2.6 per cent decline in the S&P BSE Sensex. It was trading at its highest level since July 2011. (Read more)
