601. On April 29, the Maharashtra Cabinet approved the country's first-of-its-kind gene bank programme in the State. The programme is aimed at conserving native biodiversity to ensure that natural resources are passed on to the next generation. Rajiv Gandhi Science & Technology Commission, under the State government, ran the project from 2014-2019 in different parts of the State. The project will be carried out by a three-tier panel with the Chief Secretary as head of the State-level committee. A budget of ₹172.39 Cr for 5 years has been approved for this purpose. {Read more} **Key Points:**

603. In April 2022, Tamil Nadu Assembly adopted two Bills to limit the Governor's power to appoint vice-chancellors (V-Cs) to 13 State universities. The legislations seek to give effect to a promise made by Chief Minister MK Stalin in Assembly in January. The two Bills - The Tamil Nadu Universities Laws (Amendment) Act, 2022, and the Chennai University (Amendment) Act, 2022 - were adopted by a voice vote. {Read more} Key Points:

The campaign aims to saturate 17 schemes of 9 Ministries in 75 selected districts across India. Selected districts are aligned with the birth places of 99 unsung heroes of Indian freedom movement. {Read more}

605. On April 28, India became the 1st country in Asia Pacific to achieve feat as IndiGO used a new technology to land plane by using its 'ATR 72-600' aircraft. The Airports Authority of India (AAI) successfully conducted a light trial using an indigenous satellite based augmentation system (SBAS) called 'GAGAN' (GPS Aided GEO Augmented Navigation) at the Kishangarh airport in Ajmer, Rajasthan. Jointly developed by the AAI and the ISRO, GAGAN is the first system developed for India and the neighbouring countries in the equatorial region. A Localizer Performance with Vertical Guidance (LPV) allows aircraft guided approaches. {Read more}

A gazette notification to this effect was issued by the Economic Affairs Department of the Finance Ministry on April 26. The commemorative coin is likely to be issued on July 2, 2023, to coincide with the 100th birth anniversary of Jawaharlal Darda. {Read more}

Depending on the level of distress, the government and the financial institutions can decide on an appropriate package of support instead of the current practice of doling out distress package to all the farmers across the board. {Read more} **Key Points:**

The consortium of 11 partners has received 8.2 million euros (\$8.78 million) of government funding to develop a common classification and standards for gathering and disclosing data on the batteries. {Read more}

On April 28, the SEBI has reduced the time taken for the listing of REITs (real estate investment trusts) and InvITs (infrastructure investment trusts) to 6 working days from the present 12 days. The new rule opens on or after June 1, 2022. The move is aimed at making the existing process of issuance of such emerging investment vehicles simpler and cost-effective. {Read more}

Science & Technology

621. On April 28, the ISRO finalised the launch of the first uncrewed mission or G1, planned for 2023, which will propel the orbital module into a 170×408-km orbit. The G1 mission will be followed by G2, the second uncrewed mission, both of which are precursors to the eventual human/crewed mission or H1 as named by the ISRO. Just as H1, the G1 too will be launched by a human-rated GSLV-Mk3 or the HRLV (Human-Rated Launch Vehicle). {Read more} **Key Points:**

622. On April 28, an anti-ship version of the BrahMos Supersonic Cruise Missile was successfully test-fired jointly by the Indian Navy and the Andaman and Nicobar Command. The Andaman and Nicobar Command is the only tri-services command of the Indian armed forces. BrahMos Aerospace, an India-Russian joint venture, produces supersonic cruise missiles that can be launched from submarines, ships, aircraft, or land platforms. BrahMos missile flies at a speed of 2.8 Mach or almost three times the speed of sound. The range of the advanced version of the missile is learnt to have been extended to around 350 km from the original 290 km. {Read more}

623. In April 2022, the NASA released an 'Equity Action Plan' to make space more accessible. NASA's equity action plan is a response to the U.S. government's 2021 executive order aimed at advancing racial equity and support for underserved communities. Under this plan, NASA plans to identify and eliminate systemic barriers and ensure representation. The space equity action plan lists four focus areas for underserved communities. By the fiscal year 2029, NASA aims to increase the number of outreach events for underserved communities by 50%. NASA will make its 50 most-requested environmental data sets of last year available on the internet, and the full transfer of NASA Earth science data to the cloud will be complete by 2025. {Read more}
