151. On August 11, Lieutenant Governor Manoj Sinha inaugurated "UMEED Market Place" under AVSAR Scheme of Airport Authority of India (AAI) at Srinagar International Airport in Jammu & Kashmir. A similar Marketplace was also opened at Jammu Airport and both the outlets will exhibit products of all 20 districts. This initiative will support local art and artisans of Self Help Groups of J&K Rural Livelihood Mission, providing a platform to market local products directly to the customers. {Read more} Key Points:

According to the data revealed by the Ministry of Petroleum & Natural Gas, a total of 95.21 lakh PNG (Domestic) connections have been provided and 4531 CNG (Transport) stations have been established by the authorized entities as on 31 May, 2022. {Read more}

153. As of August 2022, donations to political parties through Electoral Bonds (EBs) have crossed Rs 10,000 Crore mark, with parties getting another Rs 389.5 Crore through such bonds in the 21st sale of EBs conducted between July 1 and 10, according to data available from State Bank of India (SBI). As per the provisions of the EB Scheme, only the political parties registered under 'Section 29A' of the "Representation of the People Act, 1951" and have secured not less than 1% of the votes polled in the last general election to the Legislative Assembly, are eligible to receive electoral bonds. Electoral bonds are purchased anonymously by donors and are valid for 15 days from the date of issue. The bonds are issued by the SBI in denominations of Rs 1,000, Rs 10,000, Rs 1 lakh, Rs 10 lakh and Rs 1 Crore. {Read more}

Surat has been the hub of diamond cutters and polishers for decades. Lab-grown diamonds come across as replicas of the natural diamonds and they are priced at 30-40% lower than the natural diamonds. These diamonds were first manufactured by General Electric in the 1950s. {Read more}

This was in comparison to a net inflow of Rs 135 Cr in June 2022, as per the data from the Association of Mutual Funds in India (AMFI). The outflow has pulled down the asset under management of the category to Rs 20,038 Cr in July. Gold ETFs are units representing physical gold which may be in paper or dematerialised form. One gold ETF unit is equal to 1 gram of gold and is backed by physical gold of very high purity. {Read more}

The Crew Escape System (CES) takes away the Crew module of the Gaganyaan mission in case of any eventuality and rescues the astronauts. The LEM is a distinctive special purpose solid rocket motor. {Read more}

The vaccine has been developed by two institutes under the Indian Council of Agricultural Research (ICAR) - National Research Centre on Equines (NRCE), Hisar (Haryana) in collaboration with the Indian Veterinary Research Institute (IVRI), Izzatnagar (Bareilly). The vaccine is 100% effective, complying with all standards. The LSD disease was reported for the first time in India in 2019 from Odisha. The Centre has also authorised the use of goatpox vaccine to control LSD in cattle. {Read more}



Schemes & Initiatives

177. On August 8, Government has modified the earlier scheme of 'Special Central Assistance to Tribal Sub-Scheme' with nomenclature 'Pradhan Mantri Adi Adarsh Gram Yojna (PMAAGY)', for implementation during 2021-22 to 2025-26. It aims at mitigating gaps and providing basic infrastructure in villages with significant tribal population in convergence with funds available under different schemes in Central Scheduled Tribe Component. It is envisaged to cover 36,428 villages having at least 50% ST population. An amount of Rs 7,276 Cr has been approved by the Cabinet for the scheme in next 5 years. {Read more}

178. On August 11, the Union Cabinet approved continuation of Pradhan Mantri Awas Yojana (Urban) till December, 2024. Launched in June, 2015, the original deadline for the scheme - 'Housing for All' Mission (aimed at providing pucca houses to all eligible urban beneficiaries) was March 2022. According to the government, financial assistance will be provided for the completion of already sanctioned 122.69 lakh houses till March 31, 2022. {Read more}

The initiative is part of the Ministry's ongoing SMILE project (Support for Marginalised Individuals for Livelihood and Enterprise) for which Rs 100 Crore has been allocated till 2025-2026. The aim of the initiative was to make the 75 municipalities "begging-free". {Read more}
