Moni is father of Tony and brother of Pret.

42. Following the final solution we can say that relationship between Geet – Kanu cannot be determined.  
Hence, the correct answer is option C.

43. Following the final solution we can say that if Sona is the sister in law of Tanu then Tony is the aunt of Geet.  
Hence, the correct answer is option B.

44. Following the final solution we can say that Pret can be either Aunt or Uncle of Tanu.  
Hence, the correct answer is option E.

45. Person's father = Only son of woman's daughter's grandfather's husband's = Woman's husband.

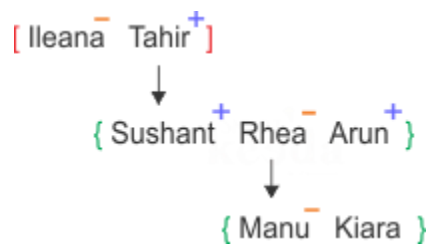

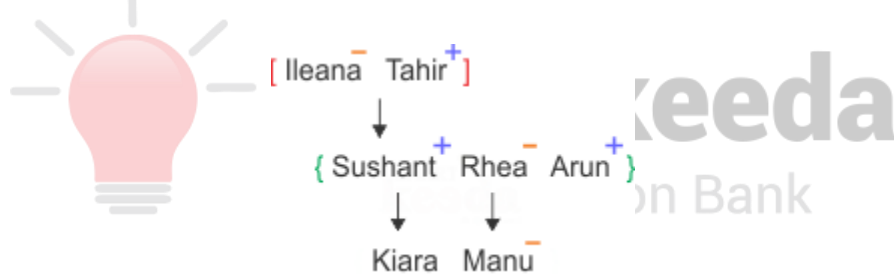
### Inference:

### Reference:

Roma is the mother of Trisha, who is the only sister of Kiara.

### Inference:

As Roma is the mother of Trisha, who is the only sister of Kiara. Thus Kiara and Trisha are siblings.

**So, Rhea can't be mother of Kiara, therefore case 1 fails.**

Thus Kiara is the daughter of Sushant and Roma is his wife.



**46.** From the following image it is clear that Arun is the maternal uncle of Kiara.

Hence option C is correct.

**47.** Following common explanation, we can say that Kiara's gender is not known and therefore Kiara could be either the granddaughter or grandson of Tahir.

Clearly, option D is the correct answer.

**48.** Clearly, Roma is the wife of Sushant who is brother in law of Micky.

Hence, option C is the correct answer.

**49.** If we can observe the statement given, except statement given in option C, all are definitely false.

Only the statement 'Kiara is a nephew of Arun' is possibly false since we are not aware of Kiara's gender.

Option C is the correct answer.

**50.** Son of Tahir's brother will be cousin of Sushant, Arun and Rhea.

Therefore, Akram will call Sushant his 'cousin'.

Option E is hence the correct answer.
