1. In December 2021, UN Women along released a report titled "Women and Girls left behind: Glaring gaps in Pandemic Responses". This was calculated using data from the "UNDP-UN Women Gender Response Tracker". The report compiled and analysed the results of Rapid Gender Assessment surveys (RGA) from April 2020-March 2021. At least 29% of working mothers living with children lost their jobs compared to only 20% of working men living with children. Women without children (single, widowed or partnered) were also less likely to receive cash relief (8% of women versus 17% of men). {Read more}

The sale of the first batch of Electoral Bonds took place from March 1-10, 2018 after the Electoral Bond Scheme was introduced with the Finance Bill in 2017. Electoral Bonds can be purchased by both Indian & Foreign entities or citizens. And the range of an Electoral Bond remains between Rs 1,000 to Rs 1 Cr.
