National & States Affairs

601. On December 20. Assam government approved the proposal by the Tourism department to grant industry status to the tourism sector in the state. The cabinet meeting chaired by chief minister, Himanta Biswa Sarma approved the proposal to boost fresh investments into the tourism infrastructure through public-private partnerships (PPP). With this, hotels, restaurants, cafeterias, health clubs, spas and wellness centres among others are eligible for incentives under the industrial policy. {Read more}

On December 22, Minister of State for Environment, Forest and Climate Change, Ashwini Kumar Choubey, announced that the Project Lion document titled "Lion@47: Vision for Amrutkal" plan has been unveiled for the conservation of Asiatic lions in the Gir landscape of Gujarat. It has been prepared with the objectives to secure & restore lions' habitats for managing its growing population; scale up livelihood generation and participation of local communities; become a global hub of knowledge on big cat disease diagnostics and treatment and create inclusive biodiversity conservation through project lion initiative. The Minister further informed that Project Tiger is being implemented in tiger landscapes spread across the country in 53 tiger reserves. Financial assistance of Rs 124.58 lakh have been provided to State of Gujarat for conservation of wildlife including Asiatic Lions under the Centrally Sponsored Scheme (CSS) - 'Development of Wildlife Habitats' during last 3 years. {Read more}

604. On December 21, Ministry of Finance, in its "Mid-Year Expenditure and Revenue Statement", announced that India's economic growth, measured by growth in GDP at constant prices, has been estimated at 9.7% for the first half (April-September) of FY23, as compared to 13.7% in H1FY22 and 4.7% in H2 of FY22. {Read more}

605. With 132.34 metric tonnes (MT) of gold purchase, RBI emerged as the largest buyer of this yellow metal among central banks between April 2020 and September 2022. Also, RBI was the top gold buyer among its peers in 2020 while it stood third in 2021. At the end of March 2022, RBI's gold reserve stood at 760.42 MT that went upto 785.35 MT at the end of September 2022. {Read more}

606. On December 23, the National Stock Exchange of India (NSE) received in-principle approval from the Securities Exchange Board of India (SEBI) to set up Social Stock Exchange (SSE) as a separate segment of the NSE. Through this exchange, such organisations can raise capital through equity or debt instruments. Peer BSE had received in-principle approval for setting up an SSE in October. To enable fundraising for not-for-profit organisations, the government had announced a new security called "Zero Coupon Zero Principal" under the Securities Contracts Regulations Act. In its circular of July, the SEBI had specified minimum requirements to be met by a Non-Profit Organisation (NPO) for registration with SSE. NPO needs to be registered as a Charitable Trust and should be registered for at least 3 years. It should have spent at least Rs 50 Lakh annually in the past financial year and should have received a funding of at least Rs 10 Lakh in the past financial year. {Read more}

607. On December 24, Bajaj Allianz General Insurance announced the launch of its unique health insurance rider 'Respect Senior Care Rider'. The intention is to minimize the worries of senior citizens and of their family members who might not be living in the same city. Anyone who is aged 50 years & above and has the company's base health insurance policy can opt for this rider. {Read more}

608. Dollar-strapped Sri Lanka and sanctions-hit Russia will be the first countries to use the 'Indian Rupee Trade Settlement Mechanism'. India's rupee trade settlement mechanism was set up by the Reserve Bank of India in July 2022. The mechanism is a means of using rupees instead of dollars and other big currencies for international transactions in order to promote growth of global trade with emphasis on exports from India and to support the increasing interest of global trading community in the rupee. With the help of a Vostro account now, instead of paying and receiving US dollars, the invoice will be made in Indian rupees if the counterparty has a Rupee Vostro account. {Read more}

609. India and Japan are set to conduct their first-ever bilateral combat air exercise named 'Veer Guardian 23' from January 16 to January 26, 2023. The Japan Air Self-Defence Force (JASDF) will conduct a bilateral fighter training with the Indian Air Force (IAF). The exercise aims to promote mutual understanding and strengthen defence cooperation between the air forces. IAF will be fielding its Russian-origin Sukhoi-30MKI aircraft. The exercise will at Hyakuri Air Base north-west of Tokyo. {Read more}

With this, it has become India's first drone start-up to get these approvals. The Made-in-India Kisan drones are developed for agricultural purposes such as reducing crop loss, crop health monitoring, yield measurement, and crop loss mitigation. {Read more}

611. On December 24, All-rounder Sam Curran became the costliest cricketer ever to be bought by any franchise of the Indian Premier League (IPL) in its 15-year history. The 24-year-old English cricketer was bought for ₹18.5 Crore by Punjab Kings in the IPL auctions held in Kerala for the 2023 season. {Read more}

On December 25, Maldives criminal court sentenced former President Abdulla Yameen to 11 years in prison and fined him \$5 million after finding him guilty of corruption and money laundering charges. He lost power in 2018 but has been declared presidential candidate for the Progressive Party of the Maldives for an election due in 2023. {Read more}

The accelerator program is supported by the Department of Science and Technology (DST) through its NIDHI scheme. It will help solve challenges in the product development journey of indigenous innovations. {Read more}

Bengaluru-based ARTPARK (AI & Robotics Technology Park), set up by the Indian Institute of Science (IISc), has teamed up with Google to unveil an all-India inclusive language data initiative for open-sourcing datasets called "Project Vaani". They have come together for an unusual digital project, mapping the language diversity of India by collecting speech sets of about a million people across 773 districts over 3 years. The project intends to record over 1,50,000 hours of speech, part of which will be transcribed in local scripts. The goal of the project is to boost the development of technologies such as automatic speech recognition, speech to speech translation and natural language understanding. With this launch, 'Vaani' joins the 'Bhasha Al' umbrella of ARTPARK and IISc's pan-India language initiatives that include SYSPIN (Synthesizing Speech in Indian languages) and RESPIN (Recognizing Speech in Indian languages). {Read more}

On December 22, Ms Shalini Kumari from Bihar, India received first prize in the 'Grassroots Innovation Competition' at the 3rd ASEAN India Grassroots Innovation forum for her innovation 'Modified walker with adjustable legs'. She has won the cash prize of USD 1,500. The technology was transferred to the industry, Vissco Rehabilitation Aids, a leading manufacturer of orthopaedic products in India. The forum was organized by the ASEAN Committee on Science, Technology and Innovation (COSTI) in partnership with the Department of Science and Technology (DST), Government of India and the National Innovation Foundation (NIF), India at Phnom Penh, Cambodia. The 2nd and 3rd prize has been won by grassroots innovators from Philippines and Myanmar, respectively. {Read more}

622. On December 20, Sethrichem Sangtam was awarded the first 'Rohini Nayyar Prize' for his outstanding contribution to rural development. Mr. Sangtam works with 1,200 marginalised farmers in Eastern Nagaland through his organisation 'Better Life Foundation', which focusses on rural livelihood security, environment sustainability and education for change. The average income of the farmers tripled as a result of his interventions. The prize had been instituted by the family of the late Dr. Rohini Nayyar, an eminent scholar-administrator who spent much of her professional life working on issues related to rural development in India. Dr. Nayyar, a well-known economist and former principal adviser at the erstwhile Planning Commission, was one of India's foremost authorities on rural development. She passed away in October 2021. {Read more}

627. On December 22, the Academy of Motion Picture Arts and Sciences released its Oscar shortlists for the 95th edition in 10 categories. The Pakistani film is among 15 films that made the cut for the best international feature film honour and will advance to the final stage of nominations. Joyland was also the first film from Pakistan to be selected for the 'Cannes Film Festival' and to win the Jury Prize in the Un Certain Regard section. {Read more}
