National & States Affairs

201. On December 10, Cyclone Mandous crossed the north Tamil Nadu coast near Mamallapuram. The cyclone claimed five lives. Cyclone Mandous had emerged as a strong cyclone as it maintained a wind speed of 65-75 kmph gusting to 85kmph as it entered the land. Its name has been given by UAE. {Read more} Key Points:

202. With an aim to end the Great Indian Red Tape, Saharsa became the first district of Bihar to be declared paperless. Red tape is a derisive term for excessive regulation or rigid conformity to formal rules that is considered redundant or bureaucratic and hinders or prevents action or decision-making. Idukki in Kerala became paperless in 2012 and Hyderabad in 2016. {Read more}

203. On December 7, Telecom Regulatory Authority of India (TRAI) floated a consultation paper about the potential introduction of Calling Name Presentation (CNAP). The feature would provide the called individual with information about the calling party (similar to 'Truecaller' and 'Bharat Caller ID & Anti-Spam'). It is to ensure that telephone subscribers are able to make an informed choice about incoming calls and curb harassment by unknown or spam callers. Comments to the consultation paper are invited until December 27. The regulator has proposed four models for facilitating the CNAP mechanism. The first model involves each telecom service provider (TSP) establishing and operating a CNAP database of its subscribers. In the second model, the operator of the calling entity shares its CNAP database with the receiver's operator. The third model envisages a third party operating a centralised database. The fourth model would require that each TSP maintain a CNAP database and retain a copy of a synchronised central database operated by a third party. DoT has requested TRAI to explore the feasibility and network readiness of providing CNAP to all telephone subscribers, including feature-phone users. {Read more}

204. Kirit Parikh Committee, which was constituted in September to review gas prices in India, has recommended in its report that India should have completely free and market-determined pricing for natural gas extracted from legacy fields and remove all caps by January 1, 2027. Till then, the committee has suggested a floor price of \$4 per MMBtu (metric million British thermal unit) be kept in place to cover the cost of gas production by Oil India (OIL) and the Oil and Natural Gas Corporation (ONGC). The committee has also recommended a ceiling price of \$6.5 per mmBtu, which may be increased yearly by about \$0.5 per mmBtu till 2027. {Read more}

205. On December 7, union minister Ashwini Vaishnaw informed the Parliament that the Indian Railways will build 100 Gati Shakti cargo terminals in the next 3 years. Such terminals will be developed under the Gati Shakti Cargo Terminal (GCT) Policy from 2022-23, 2023-24 & 2024-25. Twenty-two Gati Shakti cargos have already been commissioned, while 125 applications for development of such terminals have been received and 79 in-principle approvals have been granted. {Read more}

On December 8, the government has extended the "Rooftop Solar Programme" till March 31, 2026 and asked consumers not to pay any additional charge for solar installations as the subsidy under the programme will be available until the target under the programme is achieved. The subsidy under National Portal has been fixed at Rs 14,588 per kW (for capacity up to 3 kW) for the entire country. {Read more} Key Points:

On December 7, Meghalaya government in partnership with startup TechEagle has unveiled Asia's first drone delivery hub and network which is aimed at providing universal access to healthcare for the people in the state. The project is aimed at delivering vital supplies like drugs, diagnostic samples, vaccines, blood and blood components quickly and safely to different regions of the state using a dedicated drone delivery network. The first official drone flight took off from Jengjal Sub Divisional Hospital. {Read more}

208. On December 9, StocX.in, an online unlisted securities portal, has launched India's first private market index known as "StocX Private Market Index (SPMI)". Until now, there was no way to track the price movements of privately traded securities (i.e the stocks of companies that are not yet listed in the stock market). StocX.in claims to have achieved this by using the concepts of indexing & basic statistics. The index is built using a methodology known as 'Change Percentage'. The index is computed using 1000 as the base value as on 1 January, 2022. StocX.in is an information portal owned and operated by Blackvolt Digital Private Limited. {Read more}

209. On December 6, the government has approved the Print and Digital Media Association (PADMA) as a self-regulatory body for publishers of news and current affairs across the country. The organisation with 47 digital news publishers on board will look at grievances related to digital media news content on their platforms. The organisation will be headed by former HC Judge Mool Chand Garg and have part-time member of Prasar Bharati Ashok Kumar Tandon and journalist Manoj Kumar Mishra as members. PDMA shall perform functions laid down in the sub rules (4) and (5) of rule 12 for the purpose of redressing grievances related to the code of ethics under the rules. {Read more} **Key Points:**

International Affairs

210. On December 6, Indonesia's Parliament passed revision of its penal code that criminalizes extramarital sex for citizens and visiting foreigners alike. The amended criminal code makes sex outside marriage punishable by a year in jail and cohabitation by six months, but adultery charges must be based on police reports lodged by their spouse, parents or children. The code maintains that abortion is a crime, but it adds exceptions for women with life-threatening medical conditions and for rape, provided that the foetus is less than 12 weeks old, in line with what is already regulated in the 2004 Medical Practice Law. Indonesia, the world's fourth most populous nation and third largest democracy, proclaimed independence August 17, 1945. {Read more}

211. On December 6, Food and Agriculture Organization (FAO), organized an opening ceremony for the International Year of Millets 2023 (IYM2023) in Rome, Italy. Millets are nutritious and can be cultivated in semi-arid zones besides consuming less water for irrigation. Raising awareness to create 'Millet Mindfulness' is an important part of this movement. A pledge to include millets in their everyday food was also undertaken on the occasion. To mark the significance of the day in India, several initiatives have been taken by the Department of Agriculture & Farmers Welfare (DA&FW). The Prime Minister Shri Narendra Modi has also shared his vision to make IYM 2023 a 'People's Movement' alongside positioning India as the 'Global Hub for Millets'. In April 2018, Millets were rebranded as "Nutri Cereals", and the year 2018 was declared as the National Year of Millets. {Read more}

212. On December 9, Japan announced to jointly develop its next-generation fighter jet, Mitsubishi F-X fighter jet, with the UK and Italy, for deployment by 2035. The Mitsubishi F-X fighter jet will replace the aging fleet of F-2 that Japan previously developed with the United States. Under the fighter jet agreement, Japan's Mitsubishi Heavy Industries will partner with British defence contractor BAE Systems PLC. Italy's Leonardo S.p.A will be a key player in the project. {Read more}

213. The United Nations Panel recommended that Australia's Great Barrier Reef should be listed as a world heritage site that is "in danger", citing the world's biggest coral reef ecosystem was significantly impacted by climate change and warming of oceans. Australia's recently elected Labor government has pledged to spend \$1.2 billion (\$800 million) in coming years to protect the reef. {Read more}

214. On December 7, the RBI's 5th bi-monthly Monetary Policy Committee (MPC) met and released the Monetary Policy Statement, "2022-23 Resolution of the MPC". The RBI hiked the key repo rate by 35 basis points (bps) to 6.25% from 5.90% in its December 2022 meeting, continuing its fight against inflation. Consequently, the standing deposit facility (SDF) rate stands adjusted to 6%, and the marginal standing facility (MSF) rate and the Bank Rate to 6.50%. Reverse Repo Rate, Cash Reserve Ratio (CRR), and Statutory Liquidity Ratio (SLR) were kept unchanged at 3.35%, 4.50%, and 18%, respectively. India's real GDP forecast is slashed to 6.8% for FY23, from 7% estimated in September 2022. {Read more} Key Points:

Payment aggregators are entities which facilitate merchants and businesses to make and receive payments, pool and transfer them to the merchants within a time frame prescribed by the RBI Guidelines. {Read more}

220. On December 5, President Droupadi Murmu approved the introduction of a new design for the President's Standard and Colour and Indian Navy Crest for the Indian Navy, which was unveiled at Visakhapatnam. The new Design draws inspiration from our history. The new design of the President's Standard and Colour comprises three main constituents - the National Flag, the State Emblem underscribed with 'Satyamev Jayate' in Golden Colour, and a Navy Blue - Gold Octagon. It also includes the motto of the Indian Navy 'Sam No Varunah' in golden Devnagri script. This design was inspired by the erstwhile Naval Ensign. The Golden State Emblem signifies 'Power, Courage, Confidence and Pride' whilst the Navy Blue - Golden Octagon shape draws inspiration from Chhatrapati Shivaji Maharaj. The Indian Navy was the first among the three Services to be awarded the President's Colour on May 27, 1951, by the then President Dr Rajendra Prasad. The 22nd Missile Vessel Squadron was the first Naval Combatant Squadron to be honoured with the President's Standard. {Read more} Key Points:

IFR-22 was conducted by BN to commemorate the Birth Centenary of the Father of the Nation, Bangabandhu Sheikh Mujibur Rahman and to celebrate the Golden Jubilee of the Independence of Bangladesh. INS Kochi (based at Mumbai), INS Kavaratti (based at Visakhapatnam) and INS Sumedha (based at Visakhapatnam) are indigenously designed and developed guided missile stealth Destroyer, anti-submarine Corvette and Off-shore Patrol Vessel, respectively. {Read more} **Key Points:**

223. The three women umpires namely Vrinda Rathi, Janani Narayan, and Gayathri Venugopalan will, for the first time, officiate on-field in Ranji Trophy matches this season with the BCCI deciding to draft women umpires in the men's domestic circuit. Until now, the BCCI had never given women an opportunity to officiate as on-field umpires in men's senior tournaments. {Read more}

224. On December 10, Indian batter Ishan Kishan scored a double century off just 126 balls. Ishan Kishan has become fastest player to smash double-century in Men's ODI. He became the seventh batter in the world to achieve the feat and fourth from India after Sachin Tendulkar, Rohit Sharma and Virender Sehwag. He scored this in the third and final ODI match of the series against Bangladesh. This is also now the highest individual score against Bangladesh by any batter in men's ODI. He broke the record of Chris Gayle who reached the 200-run mark in 138 balls against Zimbabwe in 2015. Ishan Kishan has become fastest player to smash double-century in Men's ODI. {Read more} **Key Points:**

225. On December 4, Indian shuttler Unnati Hooda finished with a silver medal in the women's singles U-17 event at Badminton Asia U-17 & U-15 Junior Championships 2022 in Nothaburi, Thailand. Men's U-15 singles player Anish Thoppani and U-17 men's doubles pair of Arsh Mohammad and Sanskar Saraswat also bagged silver medals for India. Unnati Hooda is the first Indian to enter the U-17 women's singles final at the Asia Junior Championships. {Read more} **Key Points:**
