**451.** In February 20221, the High Power Committee set up by the Central government has approved the proposal to declare the "Upper Bhadra Project" as a National Project. This would enable the State to get Rs 12,500 Cr grant from the Centre to implement the project. Former Chief Minister BS Yediyurappa had laid the foundation stone for the Upper Bhadra project in 2008. This project is Karnataka's first project to get National Status. {Read more} **Key Points:**

Set up under the National Mission on Himalayan Studies (NMHS) by HP's forest department, the park was one of the dream projects of chief minister Jai Ram Thakur. {Read more}

This manned submersible is being developed by the Ministry of Earth Sciences and National Institute of Ocean Technology (NIOT), Chennai, under the aegis of Deep Ocean Mission. **456.** On February 20, the Supreme Court scrapped the 'gender cap' on performers in orchestra bars in Maharashtra. Earlier, the number of women and male performers were set to four each, however now the overall limit of performers in any given performance cannot exceed eight and the composition can be of any combination i.e. all-women, majority women or male, or vice versa. {Read more}

Durga-1 (earlier WM-Basal DD Fan-1) is the second well drilled in the Block RJ-ONHP-2017/1 to a depth of 2615 meters. This is the third hydrocarbon discovery notified by the company under the OALP portfolio. {Read more}

**458.** On February 23, Rajasthan became the first State to go back to Old Pension Scheme (OPS) for its government employees to cut down the cost of pension payout. Except West Bengal, all States and Union Territories and the Centre have New Pension Scheme, also known as National Pension System (NPS). NPS is known as 'contributory mechanism' while OPS is called 'defined mechanism'. Under OPS, employees get pension which is half of last drawn salary. However, the new mechanism is based on contributions where an employee deposits 10% of the basic pay plus dearness allowance. {Read more}

**459.** India's first-ever cable-stayed rail bridge is being constructed by Indian Railways over Anji river (Anji Khad Bridge) in the Reasi district of Jammu & Kashmir. The 'Anji Khad bridge' is a part of the Udhampur-Srinagar-Baramulla Rail Link (USBRL) project, which will connect Katra and Reasi areas of J&K through the rail link. The bridge, once ready, will stand tall at a height of 331 meters above the river bed. The total length of the bridge is 473.25 meters and it is supported by 96 cables. {Read more}

**460.** On February 24, Bharat Heavy Electricals Ltd (BHEL) successfully commissioned a 1.7 MW solar photovoltaic plant at Bina in Madhya Pradesh for the Indian Railways. The use of solar power will accelerate the mission to achieve conversion of Indian Railways to 'Net Zero' Carbon Emission Railway. This is the first of its kind project in the world commissioned by Indian Railways in collaboration with Bharat Heavy Electricals Limited (BHEL). It can produce approximately 25 lakh units of energy annually and will save around Rs 1.37 Cr for Railway every year. {Read more}

It was also announced that Delhi will have a "Delhi Film Excellence Awards" to recognize the efforts of not just actors but even the lower rung crew members. The latest policy also includes an "e-Film Clearance Portal" - a single-window system for getting approvals from all agencies. {Read more}

NBFCs - Middle Layer and NBFCs - Upper Layer with 10 and more 'fixed point service delivery units' as on October 1, 2022 shall be mandatorily required to implement CFSS. However, NBFC - Upper Layer shall ensure that the CFSS is implemented at least in 70% of 'Fixed point service delivery units' on or before September 30, 2024. Implementation of CFSS is not mandatory in the case of NBFC - Base Layer and NBFC - Middle and Upper Layers with fewer than 10 'Fixed point service delivery units'. {Read more} **Key Points:**

Resident Indian customers can now initiate Online Foreign Outward Remittances through 'SiberNet' in more than 100 currencies across the globe. The bank has further rolled out a new service feature in its 'SIB Express' Inward Remittance service. {Read more} **Key Points:**

According to the new rules, plastics have been classified into four categories - rigid plastic packaging, flexible plastic packaging of single layer, multi-layered plastic packaging & plastic sheet. Producers of plastic packaging will have to manage 35% of the 'Q1' waste in metric tonnes in 2021-22. {Read more}
