## **National & States Affairs**

101. India's first floating terminal for liquefied natural gas (LNG) at Jaigarh in Maharashtra is expected to be operational in the second half of 2022. Besides, another floating terminal at Jafrabad in Gujarat is also likely to begin operations in 2022. H-Energy Gateway's Floating Storage & Regasification Units (FSRUs) at Jaigarh and the Swan Energy-led terminal at Jafrabad are cumulatively expected to add 11 million tonnes per annum (mtpa) of regasification capacity, according to the International Gas Union (IGU). At present, India has six operational import terminals. In FY22, India imported 30,776 million standard cubic metres (MSCM) of LNG worth \$13.4 billion. During April-May of FY23, the world's 4th largest LNG importer, India, shipped 4,949 MSCM LNG worth \$2.2 billion. {Read more}

**102.** On July 1, the Indian government has imposed taxes on Windfall gains made by crude oil producers. The government slapped a Rs 23,230 per tonne additional tax on domestically produced crude oil to take away windfall gains accruing to producers from high international oil prices. The government has also imposed export duties for petrol, diesel and aviation turbine fuel (ATFs) to help boost domestic supplies. {Read more} **Key Points:** ceeda

On July 8, the central government extended the tenure of the Commission (also known as Justice Rohini Commission) to examine sub-categorisation of other backward classes (OBCs), headed by former Chief Justice of the Delhi High Court, Justice G Rohini, until January 31, 2023. The panel has received 10 extensions since its constitution on October 2, 2017. The commission was set up by the President under 'Article 340' of the Indian Constitution to sub-categorise OBCs so that the benefits of reservation reach all of them. In India, OBCs get 27% reservation in jobs and education provided by the Centre. Apart from OBCs, 15% of seats and jobs have been reserved for SCs and 7.5% for STs. {Read more} **Key Points:**

The first Indian to achieve the honour was none other than Raghuram Rajan as IMF's Chief Economist and Director of Research between the years 2003 and 2006. Indian government had conferred her "Pravasi Bharatiya Samman", the highest honour conferred on overseas Indians by the government. {Read more}

## Science & Technology

**128.** On July 2, India added 540 species to its faunal database in 2021 taking the total number of animal species to 1,03,258 in India. India also added 315 taxa to the Indian flora during 2021, taking the number of floral taxa in the country to 55,048. Among the new species discovered is one species from mammal, 35 reptiles and 19 species of pisces. The new mammal species discovered is Crocidura narcondamica, a white-toothed shrew, from Narcondam Island of the Andaman and Nicobar group of islands. With 1.03 lakh species of fauna, India contributes to 6.1% of faunal diversity in the world. The details of new discoveries and new records of fauna and flora were published by Bhupendra Yadav, Minister of Environment, Forest and Climate Change, at the headquarters of the Zoological Survey of India (ZSI) in Kolkata. {Read more} **Key Points:**

While other was a species of eel, belonging to congrid eels group, and was named 'Ariosoma albimaculata' (white spotted stout conger). The discovery was published in the international journal Fish Biology. {Read more}

Their findings were published in the journal Frontier in Genetics.
