

## **National & States Affairs**

**401.** On July 20, Himachal Pradesh Chief Minister Jai Ram Thakur, inaugurated Vehicle Location Tracking Device (VLTD), Emergency Panic Button System, and Command Control Centre of the State Transport Department for the public. This VLTD has been connected with Emergency Response Support System (ERSS) 112. With this, the vehicle registered in Himachal Pradesh and equipped with this device could be tracked anywhere in the country. This has made Himachal Pradesh the first state in the country to launch such an initiative. {Read more}

**402.** On July 20, the Supreme Court accepted the report of the Jayantkumar Banthia Commission paving way for reservation for OBCs in Local Body Elections in Maharashtra. The Commission, in its report, recommended that OBCs should be given up to 27% reservation in local bodies. The Supreme Court's decision to accept a similar report from Madhya Pradesh to provide reservation to OBCs also helped Maharashtra's bid. The previous tripartite Maha Vikas Aghadi (MVA) government had appointed a dedicated commission under former Chief Secretary Jayant Banthia in March 2022 after the Supreme Court rejected the State Backward Class Commission (SBCC) report citing several lacunae. {Read more}

**403.** Over 1.6 lakh Indians renounced their citizenship in 2021, highest in the past 5 years, according to information provided by the Ministry of Home Affairs (MHA) in the Lok Sabha on July 19. Over 78,000 Indians acquired U.S. citizenship by giving up Indian citizenship, the highest among all other countries. According to the MHA sources, the issue of citizenship comes under 'Union List' in the Seventh Schedule of the Constitution. {Read more}

Singapore is the top investing country in R&D during CY 2021 with 40% share, followed by Germany (35%) and the US (11%). Daimler Truck Innovation Center is the Top FDI Equity inflow recipient company in R&D during CY 2021. {Read more}

**408.** On July 20, the RBI signed its renewed Statement of Commitment (SoC) to the FX Global Code. The code is a compilation of best market practices, applicable to the wholesale foreign exchange market participants covering sell-side, buy-side and financial intermediaries. The Code has been formulated by Central Banks and market participants and developed under the auspices of Bank for International Settlements (BIS), Basel. It is currently being implemented globally by the Global FX Committee (GFXC) in co-ordination with the Local FX Committee (LFXC) in each jurisdiction. The Code, which was initially launched on May 25, 2017, was subsequently reviewed holistically and the updated Code was published by Global FX Committee on July 15, 2021. {Read more}

The 64-year-old Murmu hails from the Santhal (Santals) tribe and was born in Mayurbhanj, Odisha. The tenure of incumbent President Ram Nath Kovind ended on 24 July. {Read more}
