601. On June 26, the Assam Cabinet approved formation of a joint venture company called "ARIDCL" between the State Government and the Railway Ministry to increase the Railway Network in the state. In Assam Rail Infrastructure Development Corporation Limited (ARIDCL), the state government will hold a share of 51% and the remaining 49% will be held by the Ministry. The cabinet also approved the "Assam Motor Vehicle Taxation (Amendment), 2022" for reduction of greenhouse gas emissions and streamlining existing taxation regime by incorporating "Green Tax" on older vehicles. The Cabinet decided to launch a programme 'Arohan' for classes 9 to 12 from 2022-23 to guide talented students in the 13-18 age group. {Read more}

The event was presided by Manoj Joshi, Secretary, MoHUA. Manoj Joshi also released an eBook titled "7 years of PMAY (U) 2015-2022" highlighting the achievements of the mission in 7 years. On June 24, the Bureau of Indian Standard (BIS), National Standard Body of India, has published standards (IS 17855: 2022) for Test Specifications for Lithium-ion Traction Battery Packs and Systems (Performance Testing) for Electrically Propelled Road Vehicles. This standard is formulated considering real life scenarios for an electric vehicle such as vehicle is in parking, battery system is being shipped, operating battery at low and high temperature etc., accordingly various tests are incorporated in this standard. The BIS is in the process of publishing 2 more standard related to batteries for various passenger and goods carrying vehicles. {Read more}

On June 27, Tata Power Solar Systems (TPPS), a wholly-owned subsidiary of Tata Power, has accomplished a remarkable feat by commissioning India's largest floating Solar Power Project in Kayamkulam, Kerala on a 350-acre water body, backwaters area, having an installed capacity of 101.6 MW Peak. Tata Power Solar successfully built a scaffolding platform on the water body to make the entire solar plant float on water. This project is the first one in the Floating Solar Photovoltaic (FSPV) through Power Purchase Agreement category. Earlier, the record was held by 100 MW Ramagundam Floating Solar PV Project, located in Telangana. {Read more}

On June 14, China emerged as the top buyer of Indian rice during the pandemic, with the import of 16.34 lakh metric tonnes (LMT), or 7.7% of India's total rice export of 212.10 LMT in financial year 2021-22, according to an analysis of trade data. The analysis shows that out of China's total rice import from India, nearly 97% (15.76 LMT) was broken rice. China is now the top buyer of Indian broken rice, which was earlier exported mostly to African countries. During 2021-22, India exported 38.64 LMT of broken rice to 83 countries. In 2021-22, India's total rice exports, both basmati and non-basmati, was 212.10 LMT. {Read more}

608. On June 25, the Commonwealth of Nations has admitted Gabon and Togo as its 55th and 56th members, respectively. Leaders accepted applications by these two west African countries at the closing session of the 26th "Commonwealth Heads of Government Meeting (CHOGM 2022)" in Kigali, Rwanda under the new Chairmanship of Rwandan President Paul Kagame. Rwanda was the last country to join the Commonwealth, in 2009. The Commonwealth began with 8 nations in 1949. The CHOGM 2022 was held under the theme "Delivering a Common Future: Connecting, Innovating, Transforming". External Affairs Minister S. Jaishankar led the Indian delegation to the CHOGM 2022. During the event, S. Jaishankar and UK's Foreign Secretary Liz Truss announced the establishment of a joint "India-UK Commonwealth Diplomatic Academy Programme" to train young and aspiring diplomats from both nations. {Read more}

NSE and its former officials including other entities have been under SEBI's radar over alleged irregularities. {Read more}

614. In June 2022, the Insurance Regulatory and Development Authority of India (IRDAI) has reduced the Solvency Margin requirement for General Insurers doing crop business. The decision can free up a capital of Rs 1,400 Cr, which IRDAI expects will increase the capacity of general insurers to underwrite more business. The IRDAI has been relaxing the period of admissibility of premiums due from state governments for solvency purposes from 180 days to 365 days since 2017-18. {Read more}

On June 27, State Bank of India (SBI) has received in-principle approval from the Reserve Bank of India (RBI) for its proposed "Operations Support Subsidiary" aimed at bringing down the cost-to-income ratio. The subsidiary will enable the lender to leverage its high-cost manpower for more productive services. SBI's cost to income ratio stood at 53.3% in FY22, an improvement of 240 basis points over FY19 levels. In FY22, SBI's net interest margin stood at 3.15%. {Read more} Key Points:

As per the "Goods and Services Tax (Period of Levy and Collection of Cess) Rules, 2022", notified by the Finance Ministry, the compensation cess under 28% slab will continue to be levied from July 1, 2022 to March 31, 2026. The government extended the time for levy of GST compensation cess by nearly 4 years. The GST was introduced in India with effect from July 1, 2017 and States were assured of compensation for the loss of any revenue arising on account of implementation of GST for a period of 5 years. The Centre has released the entire amount of GST compensation payable to States up to May 31, 2022. In order to meet the resource gap of States due to short release of compensation, the Centre has borrowed and released ₹1.1 lakh Cr in 2020-21 and ₹1.59 lakh Cr in 2021-22 as back-to-back loan to meet a part of the shortfall in cess collection. The Centre has repaid ₹7,500 Cr as interest cost for the borrowing in FY 2021-22 and ₹14,000 Cr is to be paid this fiscal year. {Read more}

618. On June 21, the Securities and Exchange Board of India (SEBI) imposed a penalty of 30 lakh on Reliance Industries Limited (RIL) and two of its compliance officers, Savithri Parekh and K. Sethuraman, for not promptly disclosing the stake sales in its subsidiary company, Jio Platforms to Facebook, Silver Lake and Vista Equity Partners in 2020. {Read more} Key Points:

On June 17, the government increased the upper-age limit for recruitment under the "Agnipath" scheme to 23 years from 21 years for the year 2022, amid widespread protests against the new model for enrolment of soldiers into the 3 services. Earlier, the age criterion was from 17.5 years to 21 years. At the end of 4-year tenure, each "Agniveer" will get an amount of ₹11.71 lakh as the "Seva Nidhi Package" and it will be exempted from Income Tax. {Read more} Key Points:

621. On June 26, Madhya Pradesh cricket team created history by winning their maiden "Ranji Trophy" title in 2022, beating the Mumbai team. Mumbai team has won the Ranji Trophy 41 times in the 88-year-old tournament. The current MP team is captained by Aditya Shrivastava of Bhopal. The Ranji Trophy (also known as Paytm Ranji Trophy for sponsorship reasons) is a domestic first-class cricket championship played in India between multiple teams representing regional and state cricket associations. The competition currently consists of 38 teams. The competition is named after the first Indian cricketer who played international cricket, Ranjitsinhji. {Read more}

On June 24, Hyderabad's Dhruva Space Pvt Ltd and Bengaluru's Digantara Research & Technologies Pvt Ltd were authorised by Indian Space Promotion and Authorisation Centre (IN-SPACe) to launch their payloads. With this, IN-SPACe marked the beginning of Private Space Sector launches in India. Dhruva Space's Dhruva Space Satellite Orbital Deployer and Digantara's ROBust Integrating Proton Fluence Meter (ROBI) were authorised. The payloads were launched onboard 'PSLV Orbital Experimental Module (POEM)' of 'PSLV-C53' on June 30 from Satish Dhawan Space Centre, Sriharikota. PSLV-C53 is the 55th mission of the ISRO. Meanwhile, National Remote Sensing Centre (NRSC), ISRO, organised a 3-day training course on "Bhuvan" portal utilisation. Bhuvan is a Geoportal platform of ISRO. {Read more}

On June 28, the National Aeronautics and Space Administration (NASA) successfully launched the first of a trio of sounding rocket missions, "Black Brant IX sounding rocket" to study Alpha Centauri from Arnhem Space Center, in Australia. The rocket is sent to examine X-rays in the zone of gas and dust between stars known as the interstellar medium. The second mission of the trio was the University of Colorado Boulder's "Suborbital Imaging Spectrograph for Transition region Irradiance from Nearby Exoplanet (SISTINE)" host stars. The third mission, scheduled for July 12, was another UC Boulder mission called "Dual-channel Extreme Ultraviolet Continuum Experiment (DEUCE)". {Read more}

626. On June 27, the Indian Space Research Organisation's (ISRO) Vikram Sarabhai Space Centre (VSSC) has received the Crew Module Fairing (CMF), a critical structure that will protect the Gaganyaan module carrying the astronauts during launch. The CMF was manufactured by Alpha Design Technology Limited's (ADTL) fully owned subsidiary Alpha Tocol Engineering Services in Bengaluru, while the design and specifications came from the ISRO. Adani Group holds the majority stake in ADTL. Moreover, Alpha is scheduled to sign an agreement for transfer of technology of the small satellite platform - "Indian Mini Satellite-1 (IMS-1) Bus". The IMS-1, developed by ISRO's UR Rao Satellite Centre (URSC), would enable low-cost access to space. {Read more}

According to a World Bank study, road crashes are estimated to cost the Indian economy between 5% to 7% of GDP a year.
