1. On November 1, Goa Chief Minister Pramod Sawant launched a logo of "Purple Fest" at a function held in Manohar Parrikar Memorial Hall of Sanjay Centre for Education, Porvorim. According to officials, the three-day event is to kick start in January, 2023. Purple Fest - Celebrating Diversity, is a first-of-its-kind inclusive festival that embraces, expresses and celebrates persons with disabilities (PwDs). The event was organised by the Office of State Commission for Persons with Disabilities Goa in collaboration with Directorate of Social Welfare and Entertainment Society of Goa. {Read more} Key Points:

The portal contains all the information about the mission, implementation outline, resources, implementation progress, farmer registration, blog etc., which will be useful for the farmers. Also, this website will help in promoting natural farming in India. Jal Shakti Ministry has made a roadmap to promote natural farming and identified 75 Sahakar Ganga villages in the first phase. {Read more}

On November 2, Ministry of Heavy Industries (MoHI) announced a list of safety tests that will be mandatory for Electric Vehicles (EV) manufacturers from April 2023 to receive subsidies under various EV promotion schemes like PLI Scheme for Automobile and Auto components, ACC (Advanced Chemistry Cell) and FAME II (Faster Adoption and Manufacturing of Electric Vehicles) Scheme. These tests will enhance human safety of the battery used in these vehicles by requiring checks at three levels - the battery pack, battery management system (BMS) and the cell. {Read more} **Key Points:**

4. On November 3, the Central Government approved rates of Nutrient Based Subsidy (NBS) for Phosphatic & Potassic (P&K) fertilizers for 'Rabi Season 2022-23' (October, 2022 to March, 2023). The rate of Nitrogen (N) has been fixed at Rs 98.02 per kg, Phosphorus (P) Rs 66.93 per kg, Potash (K) Rs 23.65 per kg and Sulphur (S) Rs 6.12 per kg. The rates will be effective from October 1, 2022 to March 31, 2023. A sum of Rs 54,500 Crore was allocated in the Union Budget (2022-23) for fertilizers subsidy for the 2022-23 Rabi Season, which has now increased to Rs 1,38,875 Crore. The amount of P&K and Urea Subsidy will increase to Rs 51,875 Crore and Rs 87,000 Crore, respectively. {Read more} **Key Points:**

On November 4, Megha Engineering & Infrastructures Limited (MEIL) has received the Letter of Award (LOA) for the Mongol Refinery Project, which entails building Mongolia's first oil refinery in its capital Ulaanbaatar. MEIL will build EPC-2 (Open Art Units, Utilities & Offsites, Plant Buildings) and EPC-3 (Captive Power Plants) at a cost of USD 790 million using advanced technology in Mongolia. Engineers India Limited is the Project Management Consultant for this G2G partnership project. The project is part of the Development Partnership Administration initiative of the Ministry of External Affairs. {Read more}

7. On November 2, Aegon Life Insurance launched a traditional insurance policy "iGuarantee Max Savings" that offers savings and life cover. The policyholder can choose a policy term between 5 and 20 years, depending on their savings goal. The minimum entry age for this plan is three months, and the maximum is 50 years (for regular pay, 45 years). The plan also offers add-on optional coverages through the choice of Accidental Death and Critical Illness riders. {Read more} Key Points:

Moreover, the interest rates on the Bank's Baroda Advantage Retail Term Deposit Scheme (Non-Callable) have been hiked by 10 basis points as a result of raising the Non-Callable Premium from 0.15% p.a. to 0.25% p.a. The scheme is applicable on retail term deposits from 15 Lakh to Rs 2 Crore. {Read more}

10. On November 2, Bank of India came up with limited-time 'Star Super Triple Seven Fixed Deposit' scheme. Under this scheme, depositors can earn an interest rate of 7.25% and up to 7.75% for senior citizens on a deposit for 777 days. The bank has raised the interest rate on its existing 555-day FD scheme to 6.30%. Bank of India (BOI) raised the marginal cost of funds-based lending rates (MCLRs). Bank of India's one-year MCLR will be priced at 7.95% from November 1, 2022 as against 7.80% earlier. Canara Bank has launched a special fixed deposit plan for a tenure of 666 days. According to this plan, the lender is offering an interest rate of 7% to its general customers, while senior citizens will receive 7.5% on these deposits. {Read more}

CRAs will then have to report to the SEBI their compliance with the norms as ratified by their boards of directors within one quarter from date of applicability. {Read more}

On November 4, the Monetary Policy Committee (MPC) convened a special off-cycle meeting to discuss and draft the content of the report which the RBI has to send to the central government for missing the inflation target. The meeting was chaired by RBI Governor Shaktikanta Das. All the MPC members - Michael Debabrata Patra, Rajiv Ranjan, Shashanka Bhide, Ashima Goyal and Jayanth R Varma attended the meeting. The report is to be sent by the RBI to the government under the provisions of 'Section 45ZN' of the 'RBI Act, 1934' and 'Regulation 7' of 'RBI MPC and Monetary Policy Process Regulations, 2016'. The consumer price-based inflation (CPI), or retail inflation, has been above the target range of 2-6% for 3 consecutive quarters, or 9 straight months. Retail inflation hit the 7.4% level in September, 2022. This is for the first time, since the adoption of a new monetary policy framework in 2016, that a special MPC meeting was called under Section 45ZN of the RBI Act. {Read more}

15. On November 1, the Reserve Bank of India launched the Digital Rupee (e₹-W) for the wholesale segment as part of its first pilot test program to review and improve the currency's functionality. For the wholesale segment, the pilot will test the settlement of secondary market transactions in government securities. Nine banks - SBI, Bank of Baroda, UBI, HDFC Bank, ICICI Bank, Kotak Mahindra Bank, Yes Bank, IDFC First Bank and HSBC, participated in the pilot. Use of e ₹-W (digital rupee) is expected to make the inter-bank market more efficient. In October, RBI issued a concept note on Central Bank Digital Currency (CBDC). {Read more}

On November 2, Unity Small Finance Bank Limited (Unity Bank) has launched "Shagun 366", a 1 year, 1 day fixed deposit, promising retail customers an alluring return of 7.80% p.a., while senior citizens will earn 8.30% p.a. for a 366-day tenure. This comes shortly after the humongous popularity of the recently launched 'Shagun' special Fixed Deposit. Additionally, Unity Bank raised the interest rates it pays on both callable and non-callable bulk deposits (Deposits higher than ₹2 crores). {Read more}

20. On November 2, SpaceX's "Falcon Heavy", the world's most-powerful active rocket, lifted off for the first time in more than 3 years from Florida's Cape Canaveral, US. The rocket system, consisting of three Falcon 9 boosters strapped side-by-side, took off from a SpaceX launch pad, with two satellites from the Space Force and a group of smaller satellites bound for orbit. This mission marked the first use of the rocket by the Space Force, a U.S. military branch. {Read more} **Key Points:**

21. On November 2, DRDO conducted a successful maiden flight-test of Phase-II Ballistic Missile Defence (BMD) interceptor AD-1 missile with large kill altitude bracket from APJ Abdul Kalam Island off the coast of Odisha. The AD-1 is a long-range interceptor missile designed for both low exo-atmospheric and endo-atmospheric interception of long-range ballistic missiles as well as aircraft. {Read more}

On November 4, the ISRO announced that its 'Radar Imaging Satellite-2 (RISAT-2)', weighing about 300 kg, has made an uncontrolled re-entry into the Earth's atmosphere at the predicted impact point in the Indian Ocean near Jakarta, Indonesia on October 30. RISAT-2 was launched by the PSLV-C12 launch vehicle 13 years ago in 2009. Indian System for Safe and Sustainable Space Operations Management (IS4OM) facility in ISTRAC, Bengaluru had been monitoring the re-entry for last one month utilising Multi Object Tracking Radar (MOTR) at SDSC, Sriharikota. {Read more}

- ISRO's 'RISAT-2' satellite has made an uncontrolled re-entry into Earth's atmosphere in the Indian Ocean near Jakarta
- It was launched by the PSLV-C12 in 2009 | RISAT-2 Radar Imaging Satellite-2 | MOTR Multi Object Tracking Radar
