On November 11, DigiLocker successfully completed its second level of integration with Ayushman Bharat Digital Mission and users can now digitally store health records and link them with their Ayushman Bharat health account. DigiLocker aims at the Digital Empowerment of citizens by providing access to authentic digital documents. DigiLocker had earlier completed level 1 integration with ABDM wherein the platform had added Ayushman Bharat Health Account (ABHA) creation facility. Ayushman Bharat holders can also link their health records from different Ayushman Bharat Digital Mission registered health facilities and access them via DigiLocker. Users can also scan and upload their old health records on the app. The latest integration will now enable users to utilize DigiLocker as a Personal Health Records (PHR) app. {Read more} Key Points:

353. On November 14, India's national grid operator 'Power System Operation Corporation Ltd (POSOCO)' announced to change its name to 'Grid Controller of India Ltd'. The Grid Controller of India Limited (Grid-India) operates the national load despatch centre (NLDC) and five regional load despatch centres (RLDCs). The name has been changed to reflect the critical role of grid operators in ensuring integrity, reliability, economy, resilience and sustainable operation of the Indian electricity grid. The Grid-India is also designated as the nodal agency for major reforms in the power sector such as implementation and operation of Green Energy Open Access Portal, Renewable Energy Certificate (REC) Mechanism, transmission pricing, short-term open access in transmission, deviation settlement mechanism, Power System Development Fund (PSDF), etc. {Read more}

U-field is the deepest gas discovery of the project, with gas production potential of about 3 million standard cubic metres of gas per day. {Read more}

ISDS is one of the schemes of Sheep Husbandry Department aimed at achieving breakthrough in wool and mutton production and addressing the problems of unemployment across Jammu and Kashmir. Any individual, group of individuals, self-help group, cooperative society, farmers producer organisation is eligible to apply for the scheme. The scheme also has the provision of procurement of shearing units. The department also provides breeders with all kinds of assistance during disease outbreaks to minimize the loss. {Read more}

358. On November 14, India Hydrogen Alliance (IH2A) and the government of Kerala announced the proposal to build the 'Kochi Green Hydrogen (KGH2) Hub'. The proposal envisages potential capital expenditure of USD 575 million, to build a 60-tonnes per day (TPD) green hydrogen plant with a 150 MW Electrolyser, Storage and Infrastructure, which could achieve giga-watt scale and build the hydrogen economy in Kerala. The Kochi Green Hydrogen Hub is the first of its kind in India. {Read more}

From December 1, all complaints related to GST profiteering will be dealt with by India's antitrust watchdog Competition Commission of India (CCI), in place of National Anti-Profiteering Authority (NAA). Currently, all consumer complaints of companies not passing on GST rate cut benefits are investigated by the Directorate General of Anti-profiteering (DGAP), which then submits its report to the NAA. All reports by DGAP henceforth will be submitted to CCI for its verdict. NAA was set up in November 2017 under 'Section 171A' of 'Goods and Services Tax (GST) Law' to check unfair profiteering activities by registered suppliers under GST law. {Read more}

On November 14, New Delhi-based National Museum of Natural History (NMNH), under the Ministry of Environment Forest & Climate Change and United Nations Development Programme (UNDP), jointly launched "In Our LiFEtime" campaign to encourage youth between the ages of 18 to 23 years to become message bearers of sustainable lifestyles. This was launched in a side event at the India Pavilion at COP 27, Sharm El-Sheikh in Egypt. The campaign will involve more youth in the conversation about climate change, adaptation and mitigation, and provide them a platform to share their concerns, issues and solutions with the leaders of the world. {Read more}

361. On November 15, the "Global Shield Against Climate Risks" initiative was formally launched at the Vulnerable 20 (V20) pavilion at COP27. It is a collaboration between the V20 group of finance ministers representing 58 climate-vulnerable countries and the G7. The initiative is envisioned as a social protection and insurance-based finance mechanism for loss and damage outside the UNFCCC process. The initiative will provide pre-arranged financial support designed to be quickly deployed in times of climate disasters. Pakistan, Bangladesh, Costa Rica, Fiji, Senegal, Philippines and Ghana will be the first countries to receive assistance from the Global Shield initiative. Moreover, the "Action for Water Adaptation and Resilience (AWARe)" initiative was launched by the COP27 Presidency (Egypt) in partnership with the World Meteorological Organisation (WMO) to address water security as part of climate change adaptation. {Read more}

On November 15, Indonesia signed deals with international lenders and major nations that will bring billions of dollars in funding to help the country increase its use of renewable energy and reduce its reliance on coal. The \$20 billion agreement called "Just Energy Transition Partnership (JETP)" was announced on the sidelines of the Group of 20 Summit in Bali, Indonesia. It is meant to help developing countries reduce their reliance on fossil fuels such as coal and gas that cause carbon emissions that contribute to climate change. It's an important step for Indonesia, a major exporter of coal that has abundant potential for developing cleaner energy. Participating governments - the US, Japan, Canada, Denmark, the European Union, France, Germany, Italy, Norway and the UK - are to provide a total of about \$10 billion. Major private global financial institutions that earlier pledged to support climate investment will arrange the rest. {Read more}

Dharwad-based Karnataka Vikas Grameena Bank (KVGB) and Life Insurance Corporation (LIC) of India have renewed their bancassurance agreement for selling life Insurance products through the branches of KVGB. The bank renewed the pact with LIC mainly to increase insurance penetration in rural areas. {Read more}

On November 15, as many as 9 Special Vostro Accounts have been opened with two Indian banks, UCO Bank and IndusInd Bank, after permission from the Reserve Bank of India to facilitate overseas trade in rupee. Russia's banks, Sberbank and VTB Bank, are the first foreign lenders to receive the approval after the RBI announced the guidelines on overseas trade in the rupee in July. Another Russian bank Gazprom has also opened this account with Kolkata-based UCO Bank. UCO Bank already has a vostro account-based facility in Iran. Among the 9 special vostro accounts, one is in UCO Bank, one in VTB and 6 with IndusInd Bank. {Read more}

On November 13, Finance Minister Nirmala Sitharaman announced that the government's efforts to reduce bad loans have yielded results and all 12 PSBs reported a 50% rise in combined net profit to Rs 25,685 crore in the second quarter (Q2 FY23). Bank of Maharashtra (BoM) has emerged as the top performer among public sector banks (PSBs) in terms of loan growth in percentage terms during the second quarter of 2022-23. The Pune-based bank recorded a growth of 28.62% in gross advances to Rs 1,48,216 crore at the end of September 2022, according to the quarterly report published by the Public Sector Banks (PSBs). BoM was followed by Union Bank of India with a growth of 21.54% and SBI with a growth of 18.15% in gross advances. With respect to Retail-Agri-MSME (RAM) loans, BoM registered the highest growth of 22.31% during the period under review, followed by Bank of Baroda at 19.53% and SBI at 16.51%. As far as low-cost Current Account Savings Account (CASA) deposits are concerned, BoM topped the chart with 56.27%, followed by Central Bank of India at 50.99%. {Read more}

370. The 3rd edition of the pan-India Coastal Defence Exercise "Sea Vigil-22" took place on November 15-16. The exercise was a build up towards the major "Theatre Level Readiness Operational Exercise (TROPEX)", which the Indian Navy conducts every two years. Sea Vigil and TROPEX together will cover the entire spectrum of Maritime Security challenges. This National Level Coastal Defence Exercise was conceptualised in 2018 to validate various measures that have been instituted towards enhancing maritime security since '26/11'. The exercise was conducted by the Indian Navy in coordination with the Indian Coast Guard and other Ministries entrusted with the task of maritime activities. Theatre Level Operational Readiness Exercise (TROPEX) is an inter-service military exercise involving the participation of the Indian Army, Air Force, Navy and the Coast Guard. The exercise generally commences at the beginning of each year and lasts a month. {Read more}

They are kitted out in a red, white and blue colourway, with the golden Paris 2024 logo emblazoned across their chests. With a motto of "Alone we go faster, but together we go further", Olympic Phryge and Paralympic Phryge complement each other and make each other better. Paralympic Phryge has a prosthesis and a racing blade, making it a role model for many and giving maximum visibility to people with disabilities. {Read more}



394. On November 15, the World Meteorological Organization released a report titled "State of the Climate in Asia 2021". As per the report, economic losses from drought, floods and landslides have risen in Asia, causing total damage of USD 35.6 billion and affecting nearly 50 million people. China, most in Asia, lost USD 18.4 billion due to extreme weather conditions last year, followed by India's USD 3.2 billion. The report, prepared in collaboration with the United Nations Economic and Social Commission for Asia and the Pacific (ESCAP), was presented at the COP27 in Sharm El Sheikh, Egypt. According to the ESCAP's "Asia-Pacific Disaster Reports 2021 and 2022", China would require the most annual investment in adaptation in Asia, at USD 188.8 billion, followed by India at USD 46.3 billion and Japan at USD 26.5 billion. {Read more}

The annual rankings were released by German Watch, New Climate Institute and Climate Action Network International. In the CCPI 2023, Denmark reached the best ranking. Denmark (4th) is followed by Sweden (5th) and Chile (6th). Again, no country performed well enough in all index categories to achieve an overall "very high" rating in the index. Therefore, the first three ranks in the overall ranking remain empty. India is the only G-20 country in the top 10 rank. Published annually since 2005, the Climate Change Performance Index (CCPI) is an independent monitoring tool for tracking the climate protection performance of 59 countries and the EU. {Read more}

India will need to invest \$840 billion over the next 15 years, that is an average investment of \$55 billion per annum, into urban infrastructure to effectively meet the needs of its fast-growing urban population, as per the report titled "Financing India's Infrastructure Needs: Constraints to Commercial Financing and Prospects for Policy Action" released by World Bank. The report underlines an urgent need to leverage more private and commercial investments to meet emerging financial gaps. By 2036, according to the report, 600 million people will be living in urban cities in India, representing 40% of the population which is likely to put additional pressure on the already stretched urban infrastructure. Currently, the central and State governments finance over 75% of city infrastructure, while Urban Local Bodies (ULBs) finance 15% through their own surplus revenues. Only 5% of the infrastructure needs of Indian cities are currently being financed through private sources. {Read more}
