

#### **National & States Affairs**

**451.** On October 19, the Ministry of Home Affairs (MHA) has been granted an extension for the 7<sup>th</sup> time to frame rules for the 'Citizenship Amendment Act (CAA)'. The Parliamentary Committees on Subordinate Legislation in the Rajya Sabha granted permission until December 31, 2022, while the Lok Sabha extended it till January 9, 2023. The CAA was passed by Parliament on December 11, 2019. The CAA seeks to grant Indian citizenship to persecuted minorities belonging to Hindu, Sikh, Jain, Buddhist, Parsi and Christian communities from Pakistan, Bangladesh and Afghanistan who entered India on or before December 31, 2014. Part II of the Constitution of India (Articles 5 to 11) deals with the Citizenship of India. {Read more}

**452.** On October 19, Central government put into place two action plans at the National Level to protect India's vulture population, the first in 2006 and the second, ongoing plan for 2020-2025. Acting on it, the Tamil Nadu Government formed a State-level Committee to set up an institutional framework for the effective conservation of vultures, which almost went extinct in the country at the beginning of the 21<sup>st</sup> century. In Tamil Nadu, 4 species of vultures are found - the Oriental white-backed vulture, the long-billed vulture, the red-headed vulture, and the Egyptian vulture. {Read more}

453. On October 19, Ministry of Railways announced the closure of the four-decade old Central Organisation for Modernisation of Workshops (COFMOW), New Delhi, with effect from December 1, 2022. Since its inception in 1979, the COFMOW successfully helped in the modernisation of Production Units and Workshops across the Indian Railways. Ministry of Railways had earlier wound-up major establishments like the Special Railway Establishment for Strategic and Holistic Advancement (SRESTHA), Lucknow, and the Indian Railways Organisation of Alternative Fuel (IROAF), New Delhi. Other organisations like the Central Organisation for Railway Electrification (CORE), Allahabad, and the Centre for Railway Information Systems (CRIS), New Delhi, were also likely to be closed as part of the massive restructure plan. {Read more}

**454.** On October 21, PM Narendra Modi launched 'Mission LiFE', India's programme to fight climate change, at Statue of Unity in Ekta Nagar (previously known as Kevadia) in Narmada district of Gujarat. Mission LiFE aims at following a three-pronged strategy for changing our collective approach towards sustainability - first by nudging individuals to practise simple yet effective environment-friendly actions in their daily lives (demand), secondly by enabling industries and markets to respond swiftly to the changing demand (supply) and thirdly by influencing government and industrial policy to support both sustainable consumption and production (policy). The mission also emboldens the spirit of the P3 model - Pro, Planet, People. It functions on the basic principles of 'Lifestyle of the Planet, for the Planet and by the Planet'. The mantra of Mission Life is "Lifestyle For Environment". {Read more}

**455.** On October 18, Union Minister of state for Science and Technology, Jitendra Singh launched the Single Integrated Pensioners' Portal. The portal is developed in collaboration with State Bank of India and aimed at 'Ease of Living' for the central government pensioners. The minister said that 'Bhavishya 9.0' version is being released with its integration with Pension Disbursing Banks. All remaining 16 pension disbursing banks will now begin their integration with 'Bhavishya'. 'Bhavishya' is a portal for pension payment and tracking system. It is being integrated with 'Pension Seva' portal of SBI and will enable pensioners to get all information and services at one place with a single login. 'Bhavishya' was recently rated as the 3<sup>rd</sup> best portal among all government of India service portals by National e-Governance Service Delivery Assessment (NeSDA). The minister also inaugurated 'Pre-Retirement Counselling' for about 900 officials about to retire in 2023. Besides, the Minister inaugurated a 'Pension Disbursing Bank Exhibition' in which all the 17 Pension Disbursing Banks participated to display their digital initiatives and products meant for retiring government officials. {Read more}

**456.** On October 19, marking the beginning of the 5G enabled education system in India, PM Narendra Modi launched "Mission Schools of Excellence" at Trimandir, Adalaj village near Gujarat capital Gandhinagar. The Mission has been conceived with a total outlay of Rs 10,000 Crore. The Mission will help strengthen education infrastructure in Gujarat by setting up new classrooms, smart classrooms, computer labs and overall upgradation of the infrastructure of schools in the state. The PM also recalled 'Gunotsav', a festival focussing on the quality of education. A more advanced technology-based version of the 'Gunotsav' is functioning in Vidiya Sameeksha Kendra in Gujarat. {Read more}

The MoD had earlier promulgated 'First, Second and Third Positive Indigenisation Lists' also. Details of these items are available on SRIJAN portal. They will only be procured from Indian Industry after the timelines indicated in the list. {Read more}

Two strong female entrepreneurs, Shaik Ayesha and Subi Ansari, are the founders of this new cryptocurrency. Currently, the initial price of GanderCoin is 10 rupees (in INR) which is equal to 0.13 USDT.

With the DCs, customers will be able to access support as and when they need it, without needing to search for a physical branch. {Read more}

465. On October 20, Walmart-owned payment services provider, PhonePe, is investing USD 200 million (around Rs 1,661 Crore) for building Data Centres in India. The company has already invested USD 150 million but did not specify a timeline for investing the remaining USD 50 million. The USD 150 million investments will take the overall capacity to over 14 MW spread across 3 facilities in Bengaluru, and the one inaugurated in Navi Mumbai. PhonePe, NTT and Dell Technologies launched India's first Green Data Centre with a Smart Cooling technology in Navi Mumbai. This 4.8-megawatt facility at Mahape, Navi Mumbai is built and designed with advanced alternative cooling technologies like Direct Contact Liquid Cooling (DCLC) and Liquid Immersion Cooling (LIC), a first in India. {Read more}

The deal was announced on 31 August 2021. {Read more}
