

# **National & States Affairs**

**301.** The year 2022 marks the 7<sup>th</sup> operational phase of the "Global Environment Facility Small Grants Programme" which is jointly implemented by the Ministry of Environment, Forest and Climate Change (MoEFCC), the United Nations Development Programme (UNDP) and The Energy and Resources Institute (TERI). The programme provides financial and technical support to projects that conserve and restore the environment while enhancing the lives of local communities. The grants are given to NGOs working in particular landscapes; Virudhunagar and Ramanathapuram have been chosen as two districts representing the Indian coastal region in Tamil Nadu. The project aims to study and work on the themes of biodiversity, climate change and land degradation through NGOs. {Read more}

**302.** On September 15, NITI Aayog, with Rocky Mountain Institute's (RMI) support, launched "Shoonya", an initiative to promote zero-pollution delivery vehicles by working with consumers and industry. The campaign aims to accelerate adoption of electric vehicles (EVs) in the urban deliveries segment and create consumer awareness about the benefits of zero-pollution delivery. Urban freight vehicles account for 10% of freight transportation-related CO<sub>2</sub> emissions in India, and these emissions are expected to grow by 114% by 2030. {Read more}

**303.** This year, Indore is set to create history by implementing a fully digital addressing system, making it the first city in India to do so. Rishav Gupta (IAS), CEO of Indore Smart City, and Rajat Jain, co-founder of Pataa Navigations, signed an MoU for this purpose. Pataa has developed patented technology and is working with the Indian Space Research Organization (ISRO) to develop a digital addressing system for the nation. According to reports, India is reportedly losing an estimated 75,000 crores annually as a result of its complicated addressing system. {Read more}

**304.** In September 2022, Maharashtra is the first state to enable e-registrations of first-sale property. The e-registration facility was introduced during the Covid-19 pandemic. Before the pandemic, e-registration facility was only available for leave and licence agreements, which was started in 2014. To promote e-registration of newly-bought property and instill confidence among home buyers, the Maharashtra government is adopting measure to protect the data linked to such transactions. Blockchain technology will be used to prevent duplication of original agreement documents. {Read more}

**305.** On September 14, the Election Commission of India released a new digital publication 'BLO e-Patrika' at an interactive session held at India Habitat Centre, New Delhi, with Booth Level Officers (BLOs) spread across the states in the country. Over 350 BLOs joined via video-conferencing from the office of Chief Electoral Officers (CEOs) in states/UTs and 50 BLOs joined the launch event physically. The event was a first-of-its-kind direct interaction by the Commission with the BLOs across India. {Read more}

**307.** On September 13, the Centre has constituted a 6-member Expert Committee under the Chairmanship of former SEBI Chairman M. Damodaran to suggest measures for scaling up of venture capital and private equity (VC/PE) investments. This move is an implementation of an announcement made by the Finance Minister Nirmala Sitharaman in her budget speech this year. The panel will also review issues, compliances and suggest simplifications and changes for further accelerating the growth of alternative capital to participate in the VC/PE industry. The Finance Ministry's move to set up this expert committee comes at a time when PE/VC investments have fallen to a 19-month low of \$2.2 billion in August 2022. In July this year, PE/VC investments stood at \$4.1 billion, according to a EY-IVCA report. The year 2021 saw a record PE/VC investment inflows of over \$70 billion. {Read more}

**308.** On September 14, the Union Cabinet, under the Chairmanship of PM Narendra Modi, approved the addition of several tribes to the list of Scheduled Tribes (ST) across five states. The Hatti tribe in the Trans-Giri area of Sirmour district in Himachal Pradesh, the Narikoravan and Kurivikkaran hill tribes of Tamil Nadu and the Binjhia in Chhattisgarh, were the communities newly added to the list. Further, the Cabinet approved a proposal to bring the Gond tribe residing in 13 districts of Uttar Pradesh, under the ST list from the Scheduled Caste list. In addition to this, the Cabinet also approved 'Betta-Kuruba' as a synonym for the Kadu Kuruba tribe in Karnataka. {Read more}

**309.** On September 13, Indore-based carbon credit developer and supplier EKI Energy Services (EKI) has listed a plastic project from India under a global accreditation standard. With this, EKI has become the first ever firm to list a plastic project from India with an aim to generate India's first-ever international plastic credits. The project has been listed under the Plastic Waste Reduction Standard of Verra, a Washington-based accreditation. {Read more}

The Early Intervention Centre is a comprehensive state-of-the-art facility which is dedicated to children with special needs. Children of Armed Forces personnel upto 6 years of age suffering from autism, cerebral palsy, sleep and language delay and other disabilities will benefit immensely from this venture. The Centre was inaugurated by Archana Pande, President, Army Wives Welfare Association (AWWA). {Read more}

**311.** In September 2022, the first inter-modal digital TIR pilot transport between India and Iran, which facilitates seamless and paperless cross-border transit of goods under the customs guarantee of the TIR system, was flagged off from Nhava Sheva (Jawaharlal Nehru Port) in Navi Mumbai. The International North-South Transport Corridor (INSTC) is India's vision and initiative to reduce the time taken for EXIM (Export-Import) shipments to reach Russia and Europe, and enter the Central Asian markets. Iran's Chabahar Port is the commercial transit centre for the region, especially Central Asia. Moreover, India is also participating in the development of the first phase of the Shahid Beheshti Terminal at Chabahar Port in cooperation with the Iranian government. The TIR (Transports Internationaux Routiers' or International Road Transports) system plays an important role in facilitating cross-border trade. {Read more}

**315.** According to the US Embassy in India, the US issued a record 82,000 student visas in India in the past year, with more Indian students heading to the United States to study than from any other country in the world. As per data released by the US Citizenship and Immigration Services (USCIS) earlier this year, the number of Indian students in the United States increased by over 12% in 2021. Indian students comprise nearly 20% of all international students studying in the United States. {Read more}

The augmented voice intelligence platform is integrated with ICICI Lombard's customer relationship management (CRM) systems. {Read more}

317. On September 15, the Finance Ministry has issued draft guidelines for Regional Rural Banks (RRBs) to raise resources from capital market, paving the way for raising funds via rights issue, private placement with select investors such as large banks and insurance companies, and initial public offerings (IPO). Currently, there are 43 RRBs sponsored by 12 Scheduled Commercial Banks with 21,892 branches across India. RRBs are jointly owned by the Government of India (GoI), the respective State Governments (SGs), and the Sponsor Banks (SBs), with equity contribution in the ratio (GoI: SG: SB:: 50: 15: 35). Among the parameter for selection on RRBs for capital raising include: net worth of at least ₹300 Cr in each of the preceding 3 years; minimum Capital to Risk-weighted Assets Ratio above the regulatory requirement of 9% in each of the preceding 3 years; track record of profitability - pre-tax operating profit of minimum ₹15 Cr for at least 3 out of previous 5 years, excluding extraordinary times. Further, RRBs should have return on equity of minimum 10% in 3 out of preceding 5 years; and return on assets of minimum 0.5% in 3 out of preceding 5 years. {Read more}

**318.** On September 14, State Bank of India (SBI) reached Rs 5-trillion market capitalisation (market cap) for the first time after its shares touched a record high of Rs 564.45 on September 14. With a market cap of Rs 5.03 trillion, SBI stood at the 7<sup>th</sup> position in the overall market cap ranking, according to the data from BSE. With this, SBI has become the 3<sup>rd</sup> lender in India to cross the market cap of Rs 5 trillion, after HDFC Bank & ICICI Bank. {Read more}

**319.** On September 13, Ministry of Defence has launched the 'SRIJAN' portal to promote indigenization by the Indian defence industry. 19,509 defence items, which were earlier imported by India, have been uploaded on the portal for indigenisation till date. Out of them, the Indian industry has shown interest for indigenisation of 4,006 defence items so far. To supplement this public-private endeavour, Technology Development Board (TDB), a statutory body under Department of Science and Technology, supports Ghaziabad Precision Products Pvt Ltd in manufacturing of indigenous components critical to SUKHOI-30MK1 aircraft & 1500 HP Battle Tank Engine. Sukhoi Su-30MKI aircrafts, developed by Russia, are being built by Hindustan Aeronautic Ltd (HAL). {Read more}

Now, Jadeja has 23 wickets across six Asia Cup tournaments held from 2010 to 2022. Besides, Bhuvneshwar Kumar (83 wickets) overtook Yuzvendra Chahal and became India's highest wicket-taker in T20Is. {Read more}.

Uthappa has won two IPL trophies, one for KKR and one for CSK, in 2014 and 2021 respectively. {Read more}

**322.** On September 14, the Union Cabinet, chaired by PM Narendra Modi, approved the signing of guarantees for hosting the "FIFA Under 17 Women's World Cup 2022" in India. The World Cup was scheduled to take place from 11-30 October, with matches to be held in Bhubaneshwar, Navi Mumbai and Goa. This 7<sup>th</sup> edition of the biennial youth tournament is the first-ever FIFA women's competition to be hosted by India. The Cabinet also announced that a financial outlay of Rs 10 Crore for All India Football Federation (AIFF) will be met from the budgetary allocation for the Scheme of Assistance to National Sports Federations (NSFs). {Read more}

Karnataka finished with 14 gold, 4 silver and 11 bronze medals, ahead of the second-placed Services Sports Control Board (SSCB). Karnataka's Siva S was adjudged the Best Swimmer in the men's division. In the women's division, Maana Patel of Gujarat was adjudged the Best Swimmer, with 3 gold and 1 bronze medal. {Read more}

**325.** On September 14, PM Narendra Modi met with His Majesty the King of Bhutan, Jigme Khesar Namgyel Wangchuck, in New Delhi. Both the dignitaries discussed the various ideas to further strengthen the close and unique India-Bhutan friendship. Diplomatic relations between India and Bhutan were established in 1968 after the then Indian government established a special office in Thimphu. Moreover, India has constructed three Hydroelectric Projects (HEPs) in Bhutan - Chukha HEP, Kurichhu HEP, and Tala HEP. Recently, India completed a 720 MW Mangdechhu Hydroelectric Power Project in Bhutan. {Read more}

# **Science & Technology**

326. On September 13, MeitY Startup Hub (an initiative of the Ministry of Electronics & Information Technology) and Meta launched an accelerator programme called "XR Startup Program" to support and accelerate XR technology startups across India. This initiative focuses on skilling and building technological capabilities for the metaverse, and will help shape the ecosystem for these emerging technologies, including Augmented Reality (AR) and Virtual Reality (VR) in the country. The Accelerator Program will support 40 early-stage start-ups working in XR technologies with a grant of Rs 20 lakhs each.
