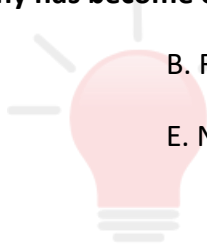

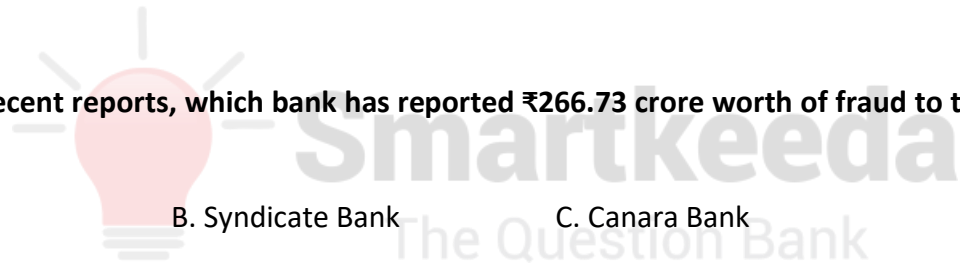

Who: India, Bangladesh

What: review progress of Line of Credit projects

When: published on 29th October 2021

The 19th India-Bangladesh Line of Credit (LOC) review meeting was held in Dhaka on 27-28 October. The meeting reviewed progress of 43 projects being taken up for implementation under the Government of India Lines of Credit (LOCs) extended to Bangladesh.

The review meeting identified the existing issues with project implementation and their possible resolution mechanisms. Detailed timelines were determined for all steps involved in project implementation. India and Bangladesh agreed that the LOC review mechanism is an ideal platform to monitor the progress of projects, understand and remove procedural bottlenecks and ensure timely implementation.

Bangladesh is the largest development partner under India's LOC programme, with four LOCs worth USD 7.862 billion extended to it for undertaking infrastructure development projects in a wide array of sectors. Approximately, USD 865 million has already been disbursed out of the total LOC till date.

The Ministry of Civil Aviation launched Krishi Udan 2.0 scheme under which cargo-related infrastructure will be built in airports of north-east, hilly and tribal regions to assist farmers in transporting agriculture products.

The Krishi Udan scheme, launched by the Centre in September 2020, waived airport charges such as parking charges and terminal navigational landing charges on select Indian airports for air cargo operators if the agricultural cargo is over 50 per cent of the total chargeable weight carried.

The Centre, under Krishi Udan 2.0, has stated that full waiver of airport charges would be granted at select airports even if the agricultural cargo is less than 50 per cent of the total chargeable weight carried.

Dr Jitendra Singh said that this niche technology shall facilitate the Ministry of Earth Sciences, MoES in carrying out deep ocean exploration of the non-living resources such as polymetallic manganese

nodules, gas hydrates, hydro-thermal sulphides and cobalt crusts, located at a depth between 1000 and 5500 meters.

Born in Lisarow on the NSW Central Coast, Davidson progressed from a homemade wicket on the family property to become a fearsome force as a destructive left-arm fast bowler and hard-hitting lower-middle order batsman for NSW and Australia.

He spend periods of his working life in hospital being treated for anaemia. When former US President Barack Obama made his historic visit to Hiroshima, he met Tsuboi.

OVER 19 months after the post was left vacant by the retirement of the then chairperson, Justice S J Mukhopadhaya, in March 2020, the Centre on Friday appointed retired Supreme Court Judge, Justice Ashok Bhushan, as the full-time chairperson of the National Company Law Appellate Tribunal (NCLAT).

Justice Bhushan, who retired from the Supreme Court in July this year, has been appointed for a period of four years, or “till he attains the age of 70 years, or until further orders”, according to the government notification.

The government also appointed retired Chief Justice of the Manipur High Court, Justice Ramalingam Sudhakar, as the chairperson of the National Company Law Tribunal (NCLT), for a period of five years,

or till he attains the age of 67 years, or until further orders. His appointment as the full-time chairperson of NCLT comes nearly 21 months after its first chairperson, Justice M M Kumar, retired in January 2020.

The 8.5 per cent rate of interest on provident fund deposits for the last financial year was decided by the EPFO's apex decision making body Central Board of Trustees (CBT) headed by labour minister in March this year.

A source said on Friday, "The rate of interest on EPF for 2020-21 has been ratified by the ministry of finance and now it would be credited into the accounts of over five crore subscribers."

The bank has reported three non-performing accounts as fraudulent.

It detailed the Non Performing Accounts (NPAs) as that have been declared as fraud and reported to RBI as per regulatory requirements, it said in the filing.

The nature of fraud for all three accounts has been specified as "Diversion of funds."

The lender has declared M P Border Checkpost Development Co Ltd as fraud with an outstanding of ₹166.89 crore, Pune Sholapur Road Development with the amount involved totaling ₹72.76 crore and M/s SONAC with an amount of ₹27.08 crore.
