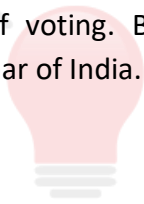

New Zealand's Greg Barclay has been elected as the new independent chairman of the International Cricket Council (ICC). The head of the New Zealand Cricket team, NZC, Barclay beat Imran Khwaja in the second round of voting. Imran was interim chairman after Shashank Manohar stepped down from the post in July this year.

In the first round of voting last week, Barclay had 10 votes to Khwaja's six, and needed 11 votes for a two-thirds majority of the 16-person ICC Board. STPL is a wholly-owned subsidiary of SJVN and executing the project. The Buxar thermal power project is expected to be commissioned in 2023-24 and generate approximately 9,828 Million Units of energy to meet the future power requirement of Bihar and other states.

**What:** is First Arab Country to generate electricity from coal

The United Arab Emirates is set to become the first Arab Gulf country to generate electricity from coal. As governments increasingly turn to cleaner fuels and the price of renewable energy falls, it may also be the last.

Dubai is starting up the \$3.4 billion Hassyan coal plant, with capacity being increased from an initial 600 mega watts to 2,400 by 2023. Japan's Jera Co. will supply coal under a long-term agreement with Acwa Power of Saudi Arabia, which is developing the plant.

Coal is typically the dirtiest fuel for power generation. Yet Hassyan's standards for pollution will be based on guidelines for natural-gas plants, according to Acwa. If met, that would mean Hassyan emits less carbon than the European Union and the World Bank's International Finance Corp. typically advise for coal plants. ([Read more](#))

The joint statement comes at a time when there is ongoing trade tension between the world's two largest economies viz. United States (US) and China.

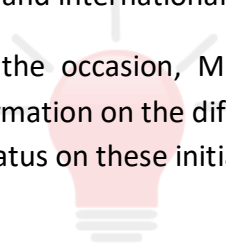

Even though the drones, MQ-9 Guardian/Predator-B, have been leased from an American firm, General Atomics, for a year for surveillance in the Indian Ocean Region, it could also be used in Ladakh, top defence sources said.

Sources told ThePrint the two drones, flying with Indian Navy logo, are under the full operational control of the force and it will have exclusive access to all the information that the drone will capture.



They added the only role of the American firm is to ensure availability of the two drones based on the contract signed. ([Read more](#))

Sadiq al-Mahdi, Sudan's last democratically elected prime minister, who was toppled in 1989 by former dictator Omar al-Bashir, died Thursday from coronavirus.

Al-Mahdi, who was 84, died in the United Arab Emirates, where he had traveled for treatment after contracting the virus, his family said in a statement.

He led Sudan as prime minister twice, first in the 1960s and again from 1986 until the 1989 coup.

As the head of the opposition National Umma Party, Al-Mahdi became one of Bashir's fiercest critics and lived long enough to witness Bashir's overthrow by the army last year amid mass protests.

Descended from the 19th century religious leader "The Mahdi of Khartoum" who fought British and Ottoman rule, Al-Mahdi also led the Ansar Sufi order, one of the largest religious groupings in Sudan.
