The person who is working in ONGC gets Rs.14000.

The one who works in HPCL is DGM.

Ranjan neither works in IOC nor works in HPCL.

Inferences:

From above statements,

Ranjan works in ONGC and he gets Rs.14000 (only possibility)

Bibin works in HPCL as DGM (only possibility)

By using above information, we get the table as follows

The Supervisor gets Rs.25000 but he is not Jenish.

The Assistant gets Rs.10000.

Inferences:

From above statements,

Finally, Tarun works in IOC as AGM.

Riyaz is a Supervisor and he gets Rs.25000 (only possibility)

Jenish works in NACL as Assistant and he gets Rs.10000 (only possibility)

Finally, Ranjan works in ONGC as GM and Tarun has gets Rs.20000.

Thus we get the completed table as follows,
