

Common Explanations (1-5):

If we read all the sentences carefully, we can observe that sentence E is the opening statement of the passage.

Further, we find two 'Mandatory Pairs' which are as follows:

D-B:

D. This **cloud** is often called a **flower**. When the flower has completely formed, the pupil or round black part of the eye can be seen to have turned white or grey, the remainder of the eye appearing healthy.

B. As long as the **cloud remains** in the pupil the person will **not** be able to **see**; if it is **removed** from the pupil and he be provided with proper glasses he will **see nearly** as well as formerly.

The highlighted parts above clearly indicate that sentence B has to follow D in the sequence cause earlier its formation is described and then its effects.

B-A:

B. As long as the **cloud remains** in the pupil the person will **not** be able to **see**; if it is **removed** from the pupil and he be provided with proper glasses he will **see nearly** as well as formerly.

This is a concluding statement where the aftermath has been talked about the two

treatments of the disease.

Thus, the correct sequence of the given sentences will be: EDBAC

Further, the correct sequence of words in sentence (B) is **remains, removed, provided and nearly**.

Clearly, 2nd sentence in the sequence is **D**.

Clearly, option B is the correct answer.

2. The 4th sentence as per the final arrangement:

The 5th sentence as per the final arrangement:

Here the 4th sentence talks about the methods of treatment and the 5th sentence talks about them in details so we can put the statement in option A in between them because it is also clarifying the details of those two methods.

Option A is hence the correct answer.


